This is a tissue paper manufacturing facility. There is one production line including a pulping phase, one paper machine, a winder and a wastewater pretreatment. Combustion sources are a 70.5 mmBtu/hr boiler, a 29.4 mmBtu/hr dryer, and two 4 mmBtu/hr space heaters. The combustion sources are subject to the requirements of 6 NYCRR 227. The facility is capped out of Title V requirements by limiting sulfur dioxide emissions to 90 tons per year, based on USEPA formulas from AP-42, which are used to calculate the SO2 emissions from the gallon usage of each permitted fuel oil (#2, #4, or #6) and cubic foot usage of natural gas.

By acceptance of this permit, the permittee agrees that the permit is contingent upon strict compliance with the ECL, all applicable regulations, the General Conditions specified and any Special Conditions included as part of this permit.

Notwithstanding the provisions of 6 NYCRR Chapter III, Subchapter A, no person shall allow or permit any air contamination source to emit air contaminants in quantities which alone or in combination with emissions from other air contamination sources would contravene any applicable ambient air quality standard and/or cause air pollution. In such cases where contravention occurs or may occur, the Commissioner shall specify the degree and/or method of emission control required.

Item C: Maintenance of Equipment - 6 NYCRR 200.7

Any person who owns or operates an air contamination source which is equipped with an emission control device shall operate such device and keep it in a satisfactory state of maintenance and repair in accordance with ordinary and necessary practices, standards and procedures, inclusive of manufacturer's specifications,
