# Interim Remedial Measure Proposed Public Comment Period Announced

The New York State Department of Environmental Conservation (NYSDEC), in consultation with the New York State Department of Health (NYSDOH), is proposing an expedited cleanup of contamination at the Church-Division St, Tower A ("site") located at 26 South Division St, New Rochelle Westchester County. Please see the map for the site location. Documents related to the cleanup of this site including the draft Interim Remedial Measure Work Plan can be found at the location(s) identified to the left under "Where to Find Information." NYSDEC is conducting a public comment period because this Interim Remedial Measure (IRM) is likely to represent a significant part of the cleanup for the site. The expedited cleanup activities are expected to begin in October 2019 and last about four months. The activities will be performed by RXR Church-Division Tower A Holdings LLC ("applicant") with oversight provided by NYSDEC.

<u>How to Comment</u>: NYSDEC is accepting written comments about the proposed plan for 30 days, from **September 18** through **October 18, 2019**. The proposed plan is available for public review at the location(s) identified at left under "Where to Find Information." Please submit comments to the NYSDEC project manager listed under Project-Related Questions in the "Who to Contact" area at left.

**Draft Interim Remedial Measure (IRM) Work Plan:** An IRM is a cleanup activity that may be performed when a source of contamination or exposure pathway (the way in which a person may contact contamination) can be effectively addressed without extensive investigation and evaluation.

The draft IRM work plan describes proposed cleanup activities that include:

- Installation of sheeting to approximately 30 feet to support the soil excavation;
- Excavating and disposing off-site contaminated soil to bedrock, which is about 17 to 22 feet below surface grade across the site;
- The removal of any underground storage tanks (USTs) that may be encountered;
- Collecting and analyzing end-point soil samples to evaluate the effectiveness of the remedy;
- Importing clean material that meets the established Soil Cleanup Objectives for use as backfill, and;
- Implementing a Health and Safety Plan and Community Air Monitoring Plan during all ground intrusive activities.

# **BROWNFIELD CLEANUP PROGRAM**

**Site Description:** The site is 0.992-acres and is bordered on the west by South Division St and on the east by Church St. The site was previously home to a garage with tire repairs and a series of upholsterers between 1892 and 1951. The most recent use was as a parking garage from 1972-2018. The parking garage has since been demolished, and the site is currently vacant.

<u>Summary of the Investigation</u>: The primary contaminants of concern at the site are metals and pesticides, which are present site-wide in soil. Chlorinated volatile organic compounds are also of concern in the soil vapor, but an on-site soil or groundwater source has not been identified. The remedial investigation is still underway and expected to be finished in the next few months.

<u>Next Steps</u>: NYSDEC will consider public comments, revise the plan as necessary, and approve the IRM work plan in consultation with the New York State Department of Health. The approved work plan will be made available to the public (see "Where to Find Information" on the front page).

When the expedited cleanup activities are completed, a Construction Completion Report will be prepared that documents the activities that were performed.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Brownfield Cleanup Program: New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
