DESIGNATION FORM FOR LICENSE REISSUANCE

Environmental Conservation Law (ECL) 13-0328(6)(a) gives DEC the authority to allow a limited entry license or permit holder to designate a member of their immediate family to whom the license or permit should be reissued in the event of the death of the license or permit holder. DEC regulations at 6 NYCRR Part 40 allows the one-time reissuance of commercial striped bass and commercial summer flounder permits in accordance with the provisions of ECL 13-0328(6)(a).

An eligible immediate family member is a:

- A husband or wife (spouse), brother or sister (sibling), parent, child, grandparent, grandchild;
- A person who is related by blood, marriage or adoption to the license or permit holder <u>AND</u> domiciled in the house of the license or permit holder. The domicile requirement only applies to individuals who are related by blood, marriage, or adoption.

The following conditions must be met for the designation of a recipient to be valid and in effect:

- 1. The designated recipient is an eligible immediate family member.
- 2. The designated recipient must be at least 16 years of age.
- 3. The license or permit holder must notify DEC of the designated recipient in writing.

If a designated family member does not wish to engage in commercial fishing, as authorized by the reissued commercial license or permit, DEC may allow the family member to identify an alternate person to whom the license or permit may be reissued. The designated family member must notify DEC of their intent regarding the license or permit in writing. Reissuance of the license or permit must be within six months of DEC being notified of the death of the original license or permit holder. If a license or permit holder chooses to not to designate an immediate family member, the license or permit holder's licenses or permits will terminate upon their death. Immediate family members will not be eligible to receive the affected licenses or permits and will have no recourse to claim eligibility in the absence of a sufficient written designation.

This Designation Form will allow a license or permit holder to identify an appropriate immediate family member to be the recipient of the reissued license or permit and to specify each license or permit to be reissued. This completed form will be kept on file at the DEC Marine Permit Office and utilized in the event of death of the license or permit holder. This designation form may be changed and resubmitted at any time. This form must be signed and notarized. Please keep a copy of this form with your records for your family's future reference.
