Acres Fee	Fee simple - an absolute interest in land over which the holder has complete freedom of disposition during their					
	Acres of land purchase through a conservation easement.					
	Conservation easement - a power invested in a qualified private land conservation organization (often called a					
	"land trust") or government (municipal, county, state or federal) to constrain, as to a specified land area, the					
	exercise of rights otherwise held by a landowner so as to achieve certain conservation purposes. It is an interest					
	in real property established by agreement between a landowner and land trust or unit of government. The					
	conservation easement "runs with the land," meaning it is applicable to both present and future owners of the					
A CF	land. As with other real property interests, the grant of conservation easement is recorded in the local land					
Acres CE	records; the grant becomes a part of the chain of title for the property.					
	In New York State, conservation easements are governed by Title 3 of Article 49 of the state's Environmental					
	Conservation Law, which defines a conservation easement as an easement, covenant, restriction or other interest					
	in real property, created under and subject to the provisions of Title 3 of article 49 of the Environmental					
	Conservation Law which limits or restricts development, management or use of such real property for the					
	purpose of preserving or maintaining the scenic, open, historic, archaeological, architectural, or natural condition,					
	character, significance or amenities of the real property in a manner consistent with the public policy and
