ENVIRONMENTAL BENEFIT PROJECTS IDEA BANK

New York State Department of Environmental Conservation's (DEC) New York City Office (DEC Region 2) wants to create an Environmental Benefit Projects Idea Bank for non-profit organizations¹ in Manhattan, Bronx, Brooklyn, Queens and Staten Island. The objective of this idea bank is to collect and store a list of ideas for potential environmental benefit projects throughout the city.

If your organization is a non-profit in New York City, DEC encourages you to provide ideas by completing the form below or by contacting Region 2 for more information.

Note that the submission of ideas to this bank is not a request for funding and does not guarantee or entitle your organization to any funding.

BACKGROUND INFORMATION

An Environmental Benefit Project (EBP) is a project that a violator of the Environmental Conservation Law agrees to fund as part of the settlement of an enforcement matter. By establishing an idea bank and compiling a list of potential EBPs, DEC hopes to identify projects that provide benefits to communities harmed by environmental violations. An EBP "must improve, restore, protect, or reduce risks to public health or the environment beyond that achieved by a respondent's full compliance with applicable laws and regulations." Selection and funding of EBPs is governed by DEC's Environmental Benefit Projects Policy CP-37.

¹**Non-Profit Organization (NPO)** - an organization that is subject to New York State's Not-For-Profit Corporation Law and qualifies for tax-exempt status under Section 501(c)(3) of the Federal Internal Revenue Code. An NPO must have an IRS 501(c)(3) determination letter, be incorporated in New York State, have a charities registration number from the NYS Office of the Attorney General and must be current in their reporting requirements to the Office of the Attorney General.



POTENTIAL PROJECT TYPES

Air Quality Improvement/Monitoring - Projects designed to improve or evaluate air quality. These could include efforts to relieve congestion, white and green roofs, tree planting, identifying or monitoring sources of emissions, and assessment of potential health impacts associated with air emissions.

Water Quality Improvement/Monitoring - Projects designed to improve or evaluate water quality. These could include watershed restoration, identifying or monitoring sources of water pollution, and assessment of potential health and environmental impacts associated with water quality.

Storm Recovery - Projects designed to repair and restore areas previously impacted by storms or natural disasters. These could include rebuilding damaged ecosystems and fortification efforts to mitigate future storm risks.

Environmental Restoration/Habitat Improvement - Projects designed to assist and maintain an ecosystem that has been degraded, damaged or destroyed. These could include wetland reconstruction, addressing environmental contamination of soil and water, and reintroducing native flora and fauna.

Pollution Prevention/Reduction - Projects designed to reduce, eliminate or prevent the amount of waste produced.

Environmental Education/Public Awareness - Projects designed to increase and promote awareness on various environmental topics.

Energy Efficiency - Projects designed to improve energy use and production. These could include conducting energy assessments and audits, structural insulation, energy-efficient lighting, high-efficiency heating systems, conversions to renewable energy, and other strategies used to reduce energy waste.

Climate Change Preparedness - Projects designed to prepare for and study the effects of climate change. These could include community-based resiliency efforts, mitigating greenhouse gas emissions, and other approaches for protecting the community and environment from climate impacts.

Stormwater Mitigation/Green Infrastructure - Projects designed to limit and/or control stormwater runoff. These could include feasibility studies and the installation of rain gardens, tree pits, bioswales/greenstreets, bluebelts, green roofs, blue roofs, permeable paving, cisterns/rain barrels, and other systems that absorb and filter stormwater runoff.

Other - Project ideas that have environmental benefits but do not fit within the categories listed above.
