### Get in on 'The Importance of Wastewater Treatment' Poster Contest

Sponsored by NYS Department of Environmental Conservation and the New York Water Environment Association

#### Great Contest Theme

Ever wondered where the water from your sinks, showers, bathtubs, toilets, washing machines and dishwashers goes when it leaves your home? This used water, or 'wastewater', must be cleaned before it can be released to the environment. At a wastewater treatment plant, this water is treated to remove dangerous, disease causing bacteria and suspended solids before the remaining water, called effluent, is discharged back to the environment. If not for wastewater treatment, untreated wastewater from our homes and businesses would pollute the lakes and streams that we fish and swim in.

#### Show how wastewater treatment plants must protect our waters!

Posters must clearly convey this message.

#### Poster Requirements

Posters must contain original hand-drawn (no computer generated posters or graphics) artwork. Copyrighted characters (such as Superman, SpongeBob, etc.), and clip art **will not be accepted**.

**Material:** You may use any variety of media, including watercolor, pen and ink, crayon, chalk and markers.

**Size:** Minimum: 16" x 20" Max: 20" x 28"

**Poster:** White Only (No Colored Paper Backgrounds)

*Keep in mind that posters will be on public display and should be easy to see or read. Winning posters will be printed and distributed as an 18" x 24" poster.*

#### Prizes and Awards

Each of the Winners (1 High School and 1 Middle School) will receive a check for \$50.

The eight other students in the top five will receive a check for \$25.

All students in the top five receive an engraved plaque.

All students who participated in the contest will receive a certificate of appreciation.

Both winning posters will be printed and distributed to municipal wastewater treatment plants throughout New York State.

The teachers of the winning students (1 High School and 1 Middle School) will receive an engraved plaque and a Water Test Kit for use in the classroom.

#### Who's eligible?

All Middle and High School students in New York State public and private schools. **One student per poster, please.**

#### Judging Procedure

Department of Environmental Conservation staff will review all posters and pick the top-five Middle School and top-five High School entries. NYWEA membership will vote for the winning Middle and High School poster.

#### Judging Criteria

1. Clear and correct message conveyed by text and artwork
2. Creativity, originality, and artistic quality
3. Visual clarity
