Statutory Authority: Environmental Conservation Law

Section 11-1905, 11-0103(4)(b)(c) and 6 NYCRR Parts 153.1, 175 and 189

Individuals who possess a valid Domestic Game Animal Breeder Class B License must complete and submit the Game Animal Breeder Annual Report prior to March 31 of each year. The report year runs from March 1 through February 28. The following instructions correspond numerically with the numbers of the Domestic Game Animal Breeder License Annual Report. When completing this form, please provide sufficient detail to fully answer the questions. Incomplete or vague forms will be returned to the licensee.

1. Please enter the following in the spaces provided:
 - Licensee Name
 - License number
 - Licensee mailing address
 - Home and business telephone number
 - County of residence
 - Email address
2. In the spaces provided, fill in the 4-digit year (XXXX) that corresponds with the report year. Enter last year in the first space following "March 1" and enter the current year in the space following "February 28".
3. Provide the total number of captive bred white-tailed deer (WTD) possessed under your valid Domestic Game Animal Breeder License. All WTD must be accounted for in the Annual Report.
 - a. Begin with the number of WTD possessed as of March 1
 - b. Add the number born at your facility and
 - c. The number that you purchased from other facilities.
 - d. Subtract the total number of WTD that were disposed of including those harvested and kept for your own personal consumption and any WTD found dead at your facility.
 - e. The final total should be the exact number of WTD that you have in your possession on February 28
4. Enter all the applicable information from the WTD that were acquired from other facilities during the report year. Be sure to include the permanent identification numbers from each WTD acquired. If more space is needed, please attach additional sheets. The number of white-tailed deer entered must match the total number you entered in section 3.C. of the report.
5. Enter all the applicable information pertaining to the WTD that were disposed during the report year. List all WTD that were harvested for your own personal consumption or were found dead at your facility. The number of WTD disposed must match the total number you entered in section 3.D. of the report.
6. List all WTD that escaped from the licensed facility during the report year. Include the date of escape, the total number that escaped, the reason of the escape and the final disposition of the escaped animals (i.e recaptured-returned, not returned, euthanized and tested for CWD), Include all CWD testing information for euthanized deer in section 7 of the report.
7. List all WTD submitted to the NYS Department of Agriculture and Markets for CWD testing. Include the permanent identification number from each WTD tested if applicable.
8. Sign and date the form.
