**INSTRUCTIONS**

**STATUTORY AUTHORITY** Environmental Conservation Law Sections 11-0535 and 6 NYCRR Parts 182 and 175.

The Department of Environmental Conservation (DEC) may issue a license to sell or possess with the intent to sell products made from African Elephant (*Loxodonta africana*) or Asian Elephant (*Elephas maximus*) in accord with the following conditions:

African Elephant (*Loxodonta africana*) - The African elephant is listed by the Federal government as a threatened species. Only articles of African elephant ivory which were lawfully imported into the United States in accord with Federal law [16 USC Section 1533 (d)] and regulations [50 CFR Section 17.40(e)] may be sold or processed with intent to sell in New York.

Asian Elephant (*Elephas maximus*) - Asian elephant is listed by the Federal government as an endangered species. Federal law [16 USC 1538(a)(1)(F)] and regulations [50 CFR Section 17.21] restrict the sale of Asian elephant ivory. Only articles of Asian elephant ivory which may, under Federal law and regulations, be lawfully imported into the United States or sold in interstate commerce may be sold or possessed with intent to sell in New York.

Incomplete applications will be returned to the applicant.

Ensure that the name of applicant, business name, address, city, state, zip code, county, date of birth, and telephone number are correctly filled in.

Ensure to check the appropriate space provided if this applicant is for a NEW or a RENEWAL of a previous license. If this is a renewal, list the previous license number.
