## DRILLING NOTICE

Please be advised that the Navy, in conjunction with the New York State Department of Environmental Conservation, will be conducting drilling activities in your area. This work is being conducted to test groundwater at depths of 200 to 800 feet below ground surface. Volatile organic compounds (VOCs) have been detected in groundwater in the general area and this work is a continuing investigation of potential migration of the VOCs that has been found to the North.

The work will involve drilling to depths of approximately 800 feet. During the drilling, soil mixed with a natural drilling fluid (bentonite) will be removed from the boring. The removed materials will be containerized and transported to Navy property off of South Oyster Bay Road. The boring will be approximately 8 to 10 inches in diameter and access to the boring will be secured with the drilling equipment. Groundwater samples will be collected and submitted to a local laboratory to test for the presence of VOCs.

Because of the depth of the work, the drill rig and support vehicles will be present at the location for approximately 6 to 8 weeks. Once the work is completed, the area will be returned to current conditions. Similar borings are being conducted elsewhere in the general area.

The work will be conducted on the western side of Whittier Avenue, just north of Mansfield Avenue on the Town of Hempstead road right-of-ways in the grass strip between the street and the sidewalk. The exact locations were selected to avoid overhead obstructions, driveways, underground utilities, and provide sufficient open space for the drill rig and support vehicles. Work hours will be Monday through Friday approximately 8 AM to 5 PM.
