### **MONTHLY PROGRESS REPORT – JANUARY 2011**

### RCRA CORRECTIVE ACTION PROGRAM BAYER MATERIALSCIENCE LLC 125 NEW SOUTH ROAD HICKSVILLE, NEW YORK

### ACTION THIS MONTH

- A conference call with the New York State Department of Environmental Conservation (NYSDEC), New York State Department of Health (NYSDOH), Cashin Spinelli & Ferretti LLC (CSF) (representing the Town of Oyster Bay), Bayer, and ARCADIS was held on January 12, 2011 to discuss and agree upon a final remedy for the Site.
- Bayer and Simone Development's (Simone) legal counsels met to discuss access to the Simone building east of the Site for vapor intrusion (VI) investigation activities. Before considering access to the building, Simone requested a letter indicating that the NYSDEC and NYSDOH are requesting the VI investigation activities (i.e., more than just soil gas sampling on their property as identified in the NYSDEC's February 23, 2010 letter).
- A conference call with the NYSDEC and NYSDOH, Bayer, and ARCADIS was held on January 25, 2011 to discuss NYSDEC and NYSDOH comments from January 19, 2011 e-mail correspondence on the "draft" VI Investigation Work Plan. The NYSDEC and NYSDOH indicated they will provide additional comments to Bayer regarding whether to make the VI Investigation Work Plan "generic" and provide separate figures and details for a complete plan for investigation at Simone property and potentially other commercial properties south of the Site.
- ARCADIS prepared a letter responding to NYSDEC, NYSDOH, and USEPA comments on the Corrective Measures Study Report (the "CMS Report") for internal review before sending to Bayer.
- ARCADIS started revising the CMS Report based on NYSDEC, NYSDOH, and USEPA comments.

# DELIVERABLES THIS MONTH

- The "draft" VI Investigation Work Plan was sent in January 14, 2011 e-mail correspondence from ACRADIS to the NYSDEC and NYSDOH.
- A revised table presenting proposed lower reporting limits for certain volatile organic compounds (VOCs) more in line with the NYSDOH decision matrices for indoor air sampling was provided by ARCADIS in January 24, 2011 e-mail correspondence to NYSDEC and NYSDOH in response to comments on the "draft" VI Investigation Work Plan.

# ACTION NEXT MONTH

- ARCADIS will complete the above mentioned letter responding to comments on the CMS Report and submit to the NYSDEC.
- ARCADIS will revise and finalize the CMS Report for NYSDEC review and approval.
