Finally heard back from DOH. This is what they said.

1. For initial screening, DOH will accept the use of the 90th percentile values from Appendix C.2 of the NYSDOH Soil Vapor Intrusion Guidance.
2. At this time DOH is okay with the proposed reporting limits found in Table 1 (Revised). At a later time, depending on what is found, they may require lower reporting limits for some constituents.

Will Bayer submit a response letter to DEC's comments letter, or will they simply submit a revised work plan?
