

DESCRIPTION OF WORK PERFORMED AND OBSERVED
1-Tailgate H&S meeting performed before the start of the work day. 2- Air monitoring was performed with 3 monitoring stations, dust and PID's. 2- Air
3-AARCO continues to excavate the east alleyway from east to west by hand and vac truck along the gas line to a depth of~3-4' bg. The gas line is being supported by pipe between the slabs of the 2 buildings at~10' intervals.
4-EnviroTrac continues to excavate the east alleyway from the gas meter to the west to a depth of ~3-4' bg.
5-A contaminated concrete sample was collected. The pieces were selected by CDM and EnviroTrac, crushed into small pieces and then sent to the lab for waste characterization.
6-Approximetly 50' of foundation wall of 50 Dale St. collapsed due to it being undercut during yesterday's excavation. Only about 5'-8' was undercut significantly and that was enough to collapse the wall. There doesn't appear to be any rebar or wire in the slab or wall or in the connection between the wall and slab. The excavation next to 40 Dale St. was sloped and is stable.




