National Grid to Conduct Site Characterization of Former Kings County Manufactured Gas Plant Site in Sunset Park, Brooklyn Beginning in July 2014

The New York State Department of Environmental Conservation (NYSDEC), New York State Department of Health (NYSDOH) and National Grid are announcing that the Site Characterization of a former Manufactured Gas Plant (MGP) Site, located over approximately 16 acres on two parcels at 5400 and 5600 1st Avenue in the Sunset Park neighborhood of Brooklyn will begin in July2014.

Site Description

The former Kings County MGP site is located in the Sunset Park community district of Brooklyn on approximately 16 acres of land, and is bounded by Upper New York Bay to the northwest, 53rd Street to the northeast, 1st Avenue to the southeast, and 55th Street to the southwest. The former MGP was constructed by Kings County Lighting Co., a predecessor to National Grid, and operated from 1904 until sometime between 1951 and 1958, when the MGP facilities were demolished and the Site was divided and sold to third parties.

The Site and adjoining properties are heavily industrialized and have been the subjects of previous spill reports and environmental assessments by a number of parties. The data from these reports and assessments, as available, will be incorporated into the Site Characterization.

The gas produced and/or stored at the Site was provided to homes, businesses, and industries, and was used in many of the same ways natural gas is used today. Additional information on MGPs can be found at: http://www.dec.ny.gov/chemical/8430.html.

Site Characterization

In February 2007, National Grid entered into a consent order (#A2-0552-0606) with the NYSDEC that requires National Grid to investigate, and where necessary, remediate former gas manufacturing and storage sites. The former Kings County MGP is included in this consent order.

In July 2014, National Grid will begin a Site Characterization to determine whether any contamination related to the former MGP operations exists in the soil or groundwater beneath or proximate to the site. The Site Characterization will collect the data necessary to assess the presence or absence of MGP-related byproducts and will assess potential contaminant exposure pathways.

Site Characterization activities will include drilling of soil borings, installation of groundwater monitoring wells and test pits, and collection of soil and groundwater samples for chemical analysis. All work will be done under the oversight of the NYSDEC and the NYSDOH.

About the Manufactured Gas Plant Program:

NYSDEC has one of the most aggressive Manufactured Gas Plant (MGP) site investigation and remediation programs in the country. Since the problems associated with the former MGP sites were identified, NYSDEC has been working with all the utilities on a state-wide basis to identify and address the issue of MGP sites for which they may have responsibility. This effort has resulted in approximately 235 sites identified for action by the eight utilities operating in New York State. Currently we have multi-site orders or agreements with six utilities, including National Grid, and several other individual site volunteers, to address 222 MGP sites in NYS. Multi-site agreements are under negotiation with a seventh utility and several other responsible parties which have newly-identified sites.

NYSDEC continues to seek to identify any other possible MGP sites throughout the State.
