Project Update

This fact sheet is being provided to you because you have a license for space at the 2350/2340 Fifth Avenue site (the Site), or because the New York State Department of Environmental Conservation (NYSDEC) believes you may otherwise be interested in activities at the Site. NYSDEC, in consultation with Department of Health (NYSDOH), has issued a Record of Decision (ROD) dated March 2011 which outlined the remedial actions selected to address contamination at the Site.

As part of the expanded Citizen Participation activities, NYSDEC issued a fact sheet in November 2012 to all site tenants announcing a planned sampling event during which side-by-side indoor air samples would be collected by a consultant retained by NYSDEC and by the Responsible Party's (RP) consultant. That sampling took place in late November.

November 2012 Indoor Air Sampling Results:

During the November 29, 2012 indoor air sampling event, side-by-side indoor air samples were collected simultaneously by NYSDEC's consultant and by the RP's consultant. The sampling results reported by the two consultants were consistent with one other. The results indicated numerous tetrachloroethene (PCE) and trichloroethene (TCE) detections, though all detections were at concentrations below their respective NYSDOH guidance values. PCE concentrations in indoor air ranged from none detected to 25 ug/m³, and TCE concentration ranged from none detected to 1.3 ug/m³. Next Steps: The Responsible Party has arranged for access with the off-site property owners to allow vapor intrusion sampling to occur on their property in March 2013. Upon receipt of the validated lab data, the NYSDOH and NYSDEC will evaluate if additional work is needed. In addition, removal of sub-slab insulation material as detailed in the NYSDEC-approved Remedial Action Work Plan for Phase 1 of the remediation will be implemented. Details regarding Phase 2 of the remedy are also being coordinated between the RP and NYSDEC. Future fact sheets will be issued to keep the public informed of the project status.

State Superfund Program Overview: The Inactive Hazardous Waste Disposal Site Remedial Program, also known as the State Superfund Program, is New York State's program for identifying, investigating and cleaning up sites where disposal of hazardous waste is known to have occurred. The Superfund process begins with the identification of a possible source of hazardous waste contamination at a site. The identification of a site can come from many different places, such as the local county health department, a concerned citizen, or the investigation of a nearby site. Once identified these sites may go through a process of investigation, evaluation, cleanup and monitoring. For more information about the State Superfund program, visit:
