### **NYSDEC Announces Reclassification of Site on Superfund Registry; Certifies Cleanup Requirements Achieved at State Superfund Site**

The New York State Department of Environmental Conservation (NYSDEC) has determined that the cleanup requirements to address contamination related to the 2350 Fifth Avenue site (“Site”) located at 2340 and 2350 Fifth Avenue, New York, New York County under New York State's Inactive Hazardous Waste Disposal Site Remedial Program (“State Superfund”) have been met. Please see the map for the site location.

The cleanup activities were performed by 2350 Fifth Avenue Corporation (“Responsible Party”) with oversight provided by NYSDEC and New York State Department of Health (NYSDOH). NYSDEC has approved a Final Engineering Report and issued a Certificate of Completion (COC) for the site. Copies of the Final Engineering Report and notice of the COC are available at location(s) identified under “Where to Find Information” on the left side of the page.

**Completion of Project:** The following activities have been completed to achieve the remedial action objectives:

- Construction of an temporary isolation enclosure around the insulation removal area and installation of negative air pressure units for the isolation enclosure;
- Removal and off-site disposal of the insulation materials present beneath the floor slab in northwest portion of the site near room 119, and collection and analysis of endpoint samples;
- Construction and operation of a sub-slab depressurization system throughout the existing site building;
- Construction and operation of a soil vapor extraction system beneath the northwestern portion of the building;
- Injection of a chemical oxidation reagent to treat the unsaturated soils, saturated soils and groundwater at the site;
- Installation of recovery wells to delineate and recover light non-aqueous phase liquid (LNAPL) on the northern side of the site;
- Closure in-place of an underground storage tank;
- Maintenance of an existing engineered site cover consisting of concrete building foundations, sidewalks/pathways, asphalt roadways to prevent human exposure to residual contaminated soil remaining under the site;
- Implementation of Site Management Plan (SMP) for long term maintenance of the remedy including plans for: (1) Institutional and Engineering Controls (IC/ECs); (2) Monitoring; (3) Operation and maintenance; and (4) reporting; and
- Recording of an Environmental Easement to ensure implementation of SMP.

**Final Engineering Report Approved:** NYSDEC has approved the Final Engineering Report which:

- Describes the cleanup activities completed.
- Certifies that cleanup requirements have been or will be achieved for the site.

## INACTIVE HAZARDOUS WASTE DISPOSAL SITE REMEDIAL PROGRAM

- Describes any institutional/engineering controls to be used. An institutional control is a non-physical restriction on use of the site, such as a deed restriction, when contamination left over after the cleanup action makes the site suitable for some, but not all uses. An engineering control is a physical barrier or method to manage contamination such as a cap or vapor barrier.
- Certifies that a Site Management Plan for any engineering controls used at the site has been approved by NYSDEC.

The following Institutional Controls have been or will be put in place on the site:

- Environmental Easement
- Site Management Plan
- Operation and Maintenance Plan
- Institutional Control/Engineering Control Plan
- Groundwater Use Restriction
- Land Use Restriction

The following Engineering Controls have been or will be put in place on the site:

- Cover System
- Vapor Mitigation
- Soil Vapor Extraction System (SVE)

**Next Steps:** With its receipt of a COC, the remedial party is eligible to redevelop the site. In addition, the remedial party has no liability to the state for contamination at or coming from the site, subject to certain conditions.

A COC may be modified or revoked if, for example, there is a failure to comply with the terms of the order or agreement with NYSDEC.

With the issuance of the COC, NYSDEC has reclassified the site from Class 2 (significant threat to public health or environment - action required) to Class 4 (site properly closed – requires continued management).

**Site Description:** The Site is located at 2340 and 2350 Fifth Avenue in the Harlem section of Manhattan. The entire site covers approximately 1.54 acres identified as Block 1739, Lot 33 and a portion of Lot 22. A Site location map is included as Figure 1. The Site is occupied by a building comprising three connected sections: a two-story section along Fifth Avenue, a three-story section in the center of the site, and a one-story section to the west. The building was originally constructed and used as an ice cream factory. Subsequently, the building was used as a commercial laundry, which included dry cleaning operations, from 1970 to 1994. A Remedial Investigation (RI) was completed at the site in various phases between April 1997 and December 2009. Environmental samples were collected from soil, groundwater, soil vapor, ambient air, and the remaining insulation between floor slabs to characterize

the nature and extent of contamination at the Site. The RI revealed that past releases associated with dry-cleaning operations at the Site have resulted in the disposal of hazardous wastes including chlorinated VOCs such as perchloroethylene (PCE) and its breakdown products. These wastes have contaminated the soil, groundwater and soil vapor at the site. The Site was previously listed in the Registry of Inactive Hazardous Waste Disposal Site in New York State as Class 2.

**State Superfund Program Overview:** The Inactive Hazardous Waste Disposal Site Remedial Program, also known as the State Superfund Program, is New York State's program for identifying, investigating, and cleaning up sites where disposal of hazardous waste is known to have occurred. The Superfund process begins with the identification of a possible source of hazardous waste contamination at a site. The identification of a site can come from many different places, such as the local county health department, a concerned citizen, or the investigation of a nearby site. **NYSDEC Anuncia la Reclasificación de los Sitios Registrados en Superfund; Certifica los Requerimientos de Limpieza Logrados en los Sitios de Superfund a Nivel Statal**

El Departamento de Conservación Ambiental del Estado de Nueva York (NYSDEC) ha determinado que se han logrado los requisitos de limpieza para hacer frente a la contaminación relacionada al sitio 2350 Fifth Avenue ("el Sitio") situado a 2340 y 2350 Fifth Avenue, New York, Condado de New York bajo el Programa de Remediación de Sitio de Disposición Inactivo de Residuos Peligrosos del Estado de Nueva York ("Superfund Estatal"). Por favor, véase el mapa para la ubicación del sitio.

Las actividades de limpieza se realizaron por la Corporación de 2350 Fifth Avenue ("Partido Responsable") con la supervisión proporcionada por el NYSDEC y el Departamento de Salud del Estado de Nueva York (NYSDOH). NYSDEC ha aprobado un Informe Final de Ingeniería y emitió un Certificado de Cumplimiento (COC) para el sitio. Las copias del Informe Final de Ingeniería y el aviso del COC están disponibles en la(s) ubicación(es) identificadas bajo "Dónde Encuentres Información" en el lado izquierdo de la página.

**La Terminación del Proyecto:** Las actividades siguientes se han llevado a cabo para lograr los objetivos de acción de remediación:

- Construcción de un recinto de aislamiento temporal alrededor de la zona de remoción aislante y la instalación de unidades de presión de aire negativas para el recinto de aislamiento;
- Extracción y eliminación fuera del sitio de los materiales aislantes presentes debajo de la losa del piso en la parte noroeste del sitio cerca de la habitación 119, y la recogida y análisis de muestras de punto final;
- Construcción y operación de un sistema de despresurización bajo losa (SSDS) en todo el edificio;
- Construcción y operación de un sistema de extracción de vapores del suelo (SVE) por debajo de la parte noroeste del edificio;
- Inyección de reactivo de oxidación química para el tratamiento de los suelos no saturados, suelos saturados y el agua subterránea en el Sitio;
- Instalación de pozos de recuperación para delinejar y recuperar líquidos ligeros de fase no acuosa (LNAPL) en el lado norte del Sitio;
- Clausura en el lugar de un tanque de almacenamiento subterráneo (UST);
- Mantenimiento de una cubierta de sitio existente de ingeniería que consiste en los cimientos de edificios concretas, aceras/caminos, carreteras de asfalto para prevenir exposición humano al suelo contaminado residual que queda en el Sitio;
- Implementación del Plan de Manejo del Sitio (SMP) para el mantenimiento a largo plazo del recurso, incluyendo planes para: (1) Controles Institucionales y de Ingeniería (IC/ECs); (2) Vigilancia; (3) Operación y mantenimiento; y (4) la presentación de informes; y
- Grabación de una Servidumbre Ambiental para garantizar la aplicación del SMP.

**Informe Final de Ingeniería Aprobado:** NYSDEC ha aprobado el Informe Final de Ingeniería que:

- Describe las actividades de limpieza realizadas.

## PROGRAMA DE REMEDIACIÓN DE SITIO DE DISPOSICIÓN INACTIVO DE RESIDUOS PELIGROSOS

- Certifica que los requisitos de limpieza han sido o serán alcanzados para el sitio.
- Describe cualquier control institucional/de ingeniería para ser utilizado. Un control institucional es una restricción no física sobre el uso del sitio, como una restricción de la escritura, cuando la contaminación que queda después de la acción de limpieza hace que el sitio es adecuado para algunos, pero no todos los usos. Un control de ingeniería es una barrera física o método para gestionar contaminación como un casco o una barrera de vapor.
- Certifica que un Plan de Gestión del Sitio por los controles de ingeniería utilizados en el sitio ha sido aprobado por el NYSDEC.

Los siguientes Controles Institucionales han sido o serán establecidos en el sitio:

- Servidumbre Ambiental
- Plan de Gestión del Sitio
- Plan de Operación y Mantenimiento
- Plan de Control Institucional/de Ingeniería
- Restricción del Uso del Agua Subterránea
- Restricción de Uso de la Tierra

Los siguientes Controles de Ingeniería han sido o van a ser establecidos en el sitio:

- Sistema de Cubierta
- Mitigación de Vapor
- Sistema de Extracción de Vapor del Suelo (SVE)

**Pasos Siguientes:** Con la recepción de un COC, la parte remedial es elegible para redesarrollar el sitio. Además, la parte remedial tiene ninguna responsabilidad al estado para contaminación en o que procedan del sitio, sujeto a ciertas condiciones.

Un COC podrá ser modificado o revocado si, por ejemplo, hay un incumplimiento de los términos de la orden o acuerdo con NYSDEC.

Con la emisión del COC, NYSDEC reclasificará el sitio de la Clase 2 (amenaza significativa a la salud pública o el medio ambiente – acción requerida) a la Clase 4 (sitio correctamente cerrado – requiere gestión continuada).

**Descripción del Sitio:** El sitio se encuentra en 2340 y 2350 Fifth Avenue en el barrio de Harlem de Manhattan. El sitio entero cubre aproximadamente 1.54 acres identificadas como Bloque 1739, Lote 33 y una porción del Lote 22. Un mapa de ubicación del Sitio se incluye como Figura 1. El Sitio está ocupado por un edificio que consta de tres secciones conectadas: una sección de dos pisos a lo largo de la Quinta Avenida (Fifth Avenue), una sección de tres pisos en el centro del sitio, y una sección de un piso al oeste. El edificio fue originalmente construido y utilizado como una fábrica de helados. Posteriormente, el edificio fue utilizado como una lavandería industrial, que incluyó operaciones de limpieza en seco, de 1970 a 1994. Una Investigación de Remediación (IR) se terminó en el lugar en varias fases entre Abril del 1997 y Diciembre del 2009.

Las muestras ambientales se obtuvieron del suelo, aguas subterráneas, vapor del suelo, aire ambiental, y el aislamiento restante entre las losas de piso para caracterizar la clase y el alcance de la contaminación en el Sitio. La investigación de Remediación (IR) reveló que los escapes anteriores relacionadas con las operaciones de limpieza en seco en el Sitio han dado lugar a la eliminación de residuos peligrosos, incluyendo compuestos orgánicos volátiles clorados ("CVOCs") tales como el percloroetileno ("PCE") y sus productos de degradación. Estos desechos han contaminado el vapor del suelo, las aguas subterráneas y el suelo en el sitio. El Sitio fue incluido previamente en el Registro de Sitios de Disposición Inactivos de Residuos Peligrosos en el Estado de Nueva York como Clase 2.

**Perspectiva General del Programa Estatal de Superfund:** El Programa de Remediación de Sitio de Disposición Inactivo de Residuos Peligrosos, también conocido como el Programa Estatal de Superfund, es el programa del Estado de Nueva York para identificar, investigar y limpiar los sitios donde se sabe que la eliminación de residuos peligrosos han ocurrido.
