Actions Taken to Comply with the Settlement Agreement During Previous Month (September):

- Preparation of the Interim Investigation Deliverable as described in Section 6.2 of the RI/FS Work Plan continued in September 2019 and is due to the NYSDEC within 60-days of receiving the final analytical data package from the Phase 1 work. This activity also involves identification of data gaps in the Phase 1 of the RI and evaluation of additional investigations in Phase 2 of the RI.
- The borehole geophysical investigations described in Section 2.4.2 of the RI/FS Work Plan was performed on a new production well on September 5, 2019. Discrete interval groundwater sampling and hydraulic conductivity testing of this well is planned for October 2019.
- The status of the point-of-entry treatment (POET) system and non-POET location monitoring is provided in the attached tables.

<u>Plans, Reports, and Other Deliverables Required by the Settlement Agreement Completed and Submitted in the Previous Month (September):</u>

 Preliminary drafts of the borehole geophysical logs collected on September 5, 2019 were transmitted to the NYSDEC by email on September 16, 2019.

Results of Sampling, Tests and Any Other Data Received or Generated by or on behalf of Respondent During the Previous Month (September):

- Analytical results were received in September 2019 for the surface water samples collected in August 2019. This data will be uploaded to the NYSDEC once validated by the third-party data validator.
- Validated analytical result EDDs for the Phase 1b Remedial Investigation (overburden monitoring well sampling) were transmitted to the NYSDEC on September 20 and 30, 2019,
- Analytical results received during the month for the POET systems and annual raw only properties were submitted to NYSDEC/NYSDOH/RCDOH on September 4, 20, and 30, 2019. POET analytical results EDDs were submitted to NYSDEC on September 9, 20, and 30, 2019.
- Analytical results received during the month for the Town of Petersburgh treatment system were submitted to NYSDEC/NYSDOH/RCDOH on September 9 and 10, 2019. Town treatment system analytical result EDDs were submitted to NYSDEC on September 12, 2019.

Activities Undertaken in Support of the Citizen Participation Plan (CPP) During Previous Month (September):

None.

Actions, Plans and Data Scheduled for the Next Month (October):

- The final round of the Phase 1Rememdial Investigation periodic surface water sampling is scheduled for October 17, 2019.
- Discrete interval groundwater sampling and hydraulic conductivity testing of the new production well is scheduled to begin on October 21, 2019.
- A 72-hour pumping test of the new production well is planned for late October to support the permitting of the well as a public water supply.
- Analytical results are scheduled to be received for the installed POET systems and raw water only locations with no POET systems.

- Sampling of the installed POET systems and raw water only locations with no POET systems will continue.
- Installation and maintenance services of POET systems will continue.
- Installation of POET system(s) not yet completed at locations included in Exhibit C of the Settlement Agreement will
 continue if accepted by the homeowners.
- Operation and maintenance support services for the Town of Petersburgh Treatment System will continue.

Activities in Support of the Citizen Participation Plan Anticipated for the Next Month (September):

Proposed or Approved Modifications (Work Scope and/or Schedule):

• As discussed with the NYSDEC on September 3, 2019, for the recently installed production well, a packer system described in Section 6.5 of the Field Sampling Plan will be used to perform the depth-discrete groundwater profiling and hydraulic conductivity testing, planned to start on October 21, 2019.
