- On July 24, 2023, Taconic received the NYSDEC's comments on the Phase 2c RI Work Plan. Revisions to the Work Plan were initiated in July 2023.
- In anticipation of the NYSDEC's approval of the Building1 IRM Work Plan, during July 2023, Taconic solicited bids from seven potential contractors. Bids were due August 1, 2023.
- During July 2023, Taconic completed the compilation of Category B laboratory data packages as requested by the NYSDEC.
