### **ENVIRONMENTAL NOTICE**

THIS ENVIRONMENTAL NOTICE is made the 2 day of Agret 2017, by the New York State Department of Environmental Conservation (Department), having an office for the transaction of business at 625 Broadway, Albany, New York 12233.
