<u>OP Unit 2: Landfill - completed in the Fall of 1996.</u>			
<u>OP Unit 3: Supplemental Purge Well - this well was located upgradient of the Ranney Well to reduce the amount of contaminated GW that enters the Ranney Well. The Village sends quarterly analytical reports from the well to the EPA.</u>
