# Inactive Hazardous Waste Disposal Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site is shown on the map on the reverse side of this page, along with adjacent properties, including NYSDEC Brownfield Cleanup Program Site No. C734083. The Roth Steel Site has been added to the Registry as a Class 2 site that presents a significant threat to public health and/or the environment for the following reason(s):

- On-site soil is contaminated with polychlorinated biphenyls (PCBs) and metals.
- Automobile Shredder Residue is present on-site which contains hazardous waste levels of PCBs.
- Additional investigations are needed to determine the full nature and extent of contamination and the potential for human exposures.
- Actions have been recommended to address exposure associated with soil on the site.
