#### **Re Volney LF: 2005 Recertification of ICs**

Find attached a letter from Oswego County regarding the annual Recertification of Institutional Controls for the Volney LF site.

Note that, the letter includes a revised parcel map, at the end, that will be included in an upcoming revised easement (re comment #7 in the letter: concerning easement #007783, which involves the former Durfey parcel - not "Durfee," as in the letter). The original maps included with each of the three easements (i.e., #007784 and 007785) are not accurate with regard to the shape of the former Durfey parcel and do not identify the Niagara Mohawk parcel. However, since the latter easements, above, are not directly affected by those inaccuracies, it's unclear whether the County will spend the time/\$ to substitute the corrected/revised map in these easements - although I've urged them to do it for both accuracy and consistency's sake and to reduce any future confusion. We'll see.

Note also that, I'm sending a copy of the letter to Carl Cuipylo in Syracuse, to keep him informed, since he performed the 5-year inspection, where the ICs were discussed.

Russ W. Johnson, being first duly sworn, deposes and says as follows:

1. I am the Chairman of the Legislature in and for the County of Oswego, New York.

2. I am executing this Recertification pursuant to the requirements of the Consent Decree and upon the advice of the County Attorney.

3. I am aware of three (3) Environmental Protection Easements and Declarations of Restrictive Covenants regarding the Volney (a/k/a Silk Road) Landfill Superfund Site heretofore filed in the Office of the Oswego County Clerk under document numbers R-2003-007783, R-2003-007784 and R-007785 on June 12, 2003.

4. Said easements and restrictive covenants run from the County of Oswego as Grantor to and for the benefit of NYSDEC, as Grantee, and to USEPA as a third-party beneficiary on behalf of the public.

5. To my knowledge, the Environmental Protection Easements and Declarations of Restrictive Covenants are still in full force and effect and the County of Oswego hereby recertifies same, and the parcels covered thereby, to USEPA and NYSDEC as if more fully set forth herein.

6. The County of Oswego has approached Niagara Mohawk Power Corporation now known as National Grid with the intent of acquiring a restrictive covenant prohibiting the digging/drilling of any future wells on the parcel and requiring the closure of the one currently-existing well upon the establishment of municipal water service to the parcel; negotiations are continuing in this regard.

7. The easement pertaining to the former Durfee property now owned by the County of Oswego will be modified to indicate the correct acreage; however, the easement will remain in full force and effect throughout.

8. I am unaware of any actions by any agency of the United States of America, the State of New York and/or the County of Oswego, or by any Court or Judge, which would limit,


