### Re: Monthly Status Report, March 2014 NYSDEC Site 9-15-066, Cheektowaga, New York

Dear Mr. Locey:

On behalf of CBS Corporation (CBS) and the Niagara Frontier Transportation Authority (NFTA), CBS submits this monthly status report on activities undertaken in March 2014 at New York State Department of Environmental Conservation (NYSDEC) Site No. 9-15-066 in Cheektowaga, New York (the "Site") pursuant to the Order on Consent and Settlement Agreement, Index No. B9-0381-91-8, entered with NYSDEC. Under agreements among the Respondents to the Order, CBS is managing the Remedial Program, including the closure of the Operable Unit 2 (OU2) groundwater collection and treatment system.

#### 1. Site Activities and Status

- A. On March 14, 2014, CBS submitted to NYSDEC a monthly report on the status of its activities at the Site in February 2014.
- B. On March 24, 2014, CBS submitted a letter to NYSDEC acknowledging and confirming the conditions set forth in NYSDEC's correspondence of January 27, 2014 approving the revised (December 2, 2013) Work Plan for closure of the OU2 groundwater collection and treatment system.
- C. On March 31, 2014, Conestoga-Rovers & Associates, Inc. (CRA) conducted the quarterly sampling at well MW-32 in Area P at the north end of the Site. Collected samples were submitted for analysis to TestAmerica Laboratories, Inc. in Pittsburgh, Pennsylvania.

D. CBS continued preparations to implement the approved work plan for closure of the OU2 groundwater collection and treatment system. CRA will serve as the prime contractor for this activity.

## 2. Sampling Results and Other Site Data

A. CBS developed no sampling or other Site data during the March 2014 reporting period.

# **3.** Upcoming Activities

- A. CBS will participate with NFTA in meeting with NYSDEC on April 15, 2014 to discuss the scope of the Site Management Plan.
- B. CBS and CRA representatives plan to meet with NYSDEC personnel on April 16, 2014 to review storm sewer monitoring locations downgradient of the 003 segment of the groundwater collection system.
- C. CBS will continue preparations to implement the approved work plan for closure of the OU2 groundwater collection and treatment system. Such preparations include meeting with NFTA operations personnel to discuss logistical issues for the upcoming system closure.
- D. CRA is planning a late-April 2014 start for the OU2 groundwater collection and treatment system closure. Site work is expected to take approximately six weeks.

### 4. **Operational Problems**

A. There are no operational problems affecting the current planning of the OU2 groundwater collection and treatment system closure.
