Remedial Investigation Work Plan for Bethpage Community Park Ice Rink Area - Available for Public Comment

Introduction

The New York State Department of Environmental Conservation (NYSDEC) welcomes public comment as it reviews a Remedial Investigation (RI) Work Plan for the Bethpage Community Park Ice Rink Area in Nassau County. The RI Work Plan outlines an environmental investigation to be performed at the site. The volatile organic compound (VOC) impacts to soil and groundwater due to historical operations at the site are being investigated. An environmental investigation will help to further determine the nature and extent of contamination at the site as well as options for cleaning it up, if necessary. The investigation work will be performed by the Town of Oyster Bay under New York State's Brownfield Cleanup Program (BCP).

Public Comments on the Remedial Investigation Work Plan

The RI Work Plan is available for public viewing at the locations listed in this fact sheet. An electronic copy is available on NYSDEC's Region 1 Remediation web page (link provided on next page). NYSDEC will accept written public comments on the RI Work Plan for 30 days, from **Wednesday, November 6, 2013 to Thursday, December 5, 2013**. Written comments should be submitted to the NYSDEC project manager listed on the following page.

What Will the Upcoming Investigation Work Involve?

The planned remedial investigation will provide further review of existing environmental data to determine the nature and extent of contamination and assist in determining whether additional remedial measures are recommended. The RI work will include:

- Data compilation and review;
- Field investigation to determine the areal and vertical extent of VOC impacts
- Comparison to applicable standards, criteria and guidelines;
- Qualitative exposure assessment; and
- Recommendations and reporting.

Next Steps

NYSDEC will consider public comments before it approves the RI Work Plan. The New York State Department of Health (NYSDOH) must concur in the approval of the RI Work Plan. The approved plan will be available for public review at the locations listed below and on the DEC website. After receiving approval, the Town of Oyster Bay may proceed with the environmental investigation at the site. The RI is expected to begin in January 2014. NYSDEC will keep the

public informed during the investigation and follow-up activity through fact sheets similar to this one.

Site Background

The project site is located in a portion of the Bethpage Community Park in the Hamlet of Bethpage, Nassau County, New York (Site). The approximately 0.4-acre Site is situated within the northeast portion of the Park and encompasses the footprint of two former ice skating rinks, now demolished and replaced by the current indoor ice skating center. Numerous environmental investigations have been conducted in the Site area. VOCs, including various Freon™ compounds, have been identified in the groundwater in the vicinity of the Site and the soil vapor at the Site and surrounding areas.




FIGURE I. SITE LOCATION

The DEC's Division of Environmental Remediation is committed to informing and involving the public during the investigation and cleanup of contaminated sites being addressed under the State's various remedial programs. As a listserv member, you will periodically receive site-related information/announcements for all contaminated sites in the counties you select.

DEC invites you to receive site information by email by signing up through the GovDelivery service in the box below. It's quick, it's free, and it will help keep you better informed.

How To Sign Up and Receive Email Updates and News from NYSDEC

Sign up for one or more contaminated sites county listservs and have site information sent right to your email inbox.

1. Go to the following Website:

2. Enter your email address in the box marked "**Receive Email Updates and News from NYSDEC**" and click "Submit."
3. You will be taken to the GovDelivery "New Subscriber page." Here you will confirm your email, select how frequently you'd like to receive updates and choose a password (optional). Once you have done this, click "submit"
4. You will see all the topics that you can subscribe to. Scroll down to the bottom of the list to the category "Environmental Site Cleanup and Permitting Information by County"
5. Click on the + sign in the small box next to the category to expand it to see all the counties
6. Click the box by the county name to select it. You may select as many counties as you want. Click the box again to un-select a county.
7. In the last step, you will be asked to give your zip code. Enter it and click "submit."

You will get a email back from GovDelivery listing all the county listservs that you have subscribed to.
