Introduction

In accordance with the New York State Department of Environmental Conservation (NYSDEC) Brownfield Cleanup Agreement (Index #C203138), dated September 22, 2020, this Progress Report was prepared by Roux Environmental Engineering and Geology, D.P.C. (Roux) to describe the Brownfield Cleanup Program (BCP) activities at the PL Senior Site, located at 1940 Turnbull Avenue, Bronx, New York (Site). PL Sara LLC is the BCP Volunteer.

I. BCP Activities Completed during the Reporting Period

A total of 2 truckloads of soil profiled as hazardous but analytically non-hazardous, as discussed in the previous Monthly Report, were removed from the Track 4 Area. The soil was disposed of at the Clean Earth of North Jersey facility in Kearny, NJ.

CAMP was completed during the soil export on July 20, 2023. There were no exceedances reported.

Intrusive work resumed on July 20, 2023, with the asphalt cap disturbed to excavate a new utility trench located within the Track 4 cleanup area. This trench was excavated to a depth of 22 inches below surface. Utility work was completed and the trench was backfilled on July 24, 2023. The asphalt cap was restored on July 27, 2023.

No soils were excavated below the 2' soil cover, therefore no CAMP was conducted and no waste was generated during this work.

II. BCP Activities Planned for the Next Reporting Period (August 2023)

Additional utility trench work is planned within the Track 4 area to make sewer connections. Any soils removed below the 2' site cover will be exported for disposal and backfilled with approved material.

VI. Percentage of Work Completion and Any Delays

Excavation from within the extents of the Track 2 and Track 4 areas are complete, however there is one additional trench planned within the Track 4 area to make sewer connections.

Aside from the upcoming trench, the rest of the Track 4 area is sufficiently covered with a minimum 2-foot cap consisting of NYSDEC-approved sand sourced North American Aggregates/Weeks Marine, Inc. and NYSDEC-approved ¾-inch stone sourced from North Shore Terminal.

Excavation within the Track 2 area has been completed to at least 15 feet below grade, and the building foundation consisting of a waterproofing membrane and reinforced concrete elements has been installed in the Track 2 area.
