Act Now to Continue Receiving Information About This Site!

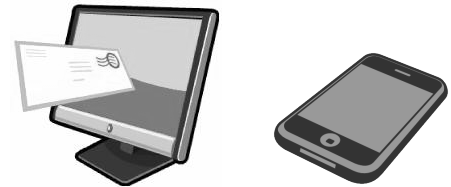
DEC's Division of Environmental Remediation (DER) now distributes information about contaminated sites *electronically by email*.

You must sign up for the DER email listserv:

DER cannot register your email address - only the email address owner can do so. If you already have signed up for the listserv for the county in which the site is located, you need do nothing.

Remedy Proposed for Brownfield Site Contamination; Public Comment Period Announced

The public is invited to comment on a proposed remedy being reviewed by the New York State Department of Environmental Conservation (NYSDEC), in consultation with the New York State Department of Health (NYSDOH), to address contamination related to the 521 East Tremont Avenue site ("Site") located at 521 East Tremont Avenue and 4223 Third Avenue, Bronx, New York. Please see the map for the Site location.

Based on the findings of previous investigations, NYSDEC in consultation with the NYSDOH has determined that the Site does not pose a significant threat to public health or the environment. This decision was based on the nature of the existing contaminants identified at the Site; the lack of potential off-site migration of contaminants in the groundwater; and the lack of potential human exposure to site-related contaminants through soil vapors. NYSDEC has developed the proposed remedy summarized below to address any potential threat.

How to Comment: NYSDEC is accepting written comments about the proposed plan, called a "Draft Remedial Action Work Plan (RAWP)" for 45 days, from **April 11 through May 25, 2024.**

Draft Remedial Work Plan: The proposed Restricted Residential Use remedy consists of:

- Excavation and off-site disposal of soil that exceeds the Restricted Residential Soil Cleanup Objectives within the upper 15 feet below surface grade within the southern half of the site (Track 2 portion) and excavation to at least 2 feet below surface grade in the northern half of the site (Track 4 portion);
- Removal and off-site disposal of underground storage tanks, fill ports and vents and any associated grossly contaminated soil, if encountered;
- Performance of an in-situ (i.e. in place) groundwater treatment program;
- Collection and analysis of post-remedial soil and groundwater samples to evaluate the effectiveness of the remedy;
- Installation of a sub-slab depressurization system to prevent vapors entering the the new building that will be constructed;

- Placement of a cover system, including a demarcation layer to address contamination remaining above cleanup standards;
- Importation of clean material that meets the established cleanup standards;
- Implementation of a Health and Safety Plan during all site activities;
- Implementation of Community Air Monitoring Plan during all ground intrusive activities;
- Implementation of Site Management Plan for long-term maintenance of the remedial systems; and
- Recording of an Environmental Easement to ensure proper use of the Site.

The proposed remedy was developed by M521 Tremont LLC and 521 Tremont Owner LLC (“Applicants”) after performing a detailed investigation of the Site under New York’s Brownfield Cleanup Program (BCP). A “Remedial Investigation Report”, which describes the results of the Site investigation was submitted to NYSDEC and is also available for review at the locations identified on Page 1.

Next Steps: NYSDEC will consider public comments, revise the cleanup plan as necessary, and issue a final Decision Document. NYSDOH must concur with the proposed remedy. After approval, the proposed remedy becomes the selected remedy. The Applicants may then design and perform the cleanup action to address the Site contamination, with oversight by NYSDEC and NYSDOH.

NYSDEC will keep the public informed throughout the investigation and cleanup of the Site.

Site Description: The Site is located at the northwest corner of the intersection of Third Avenue and East Tremont Avenue in the Bronx and is identified as Block 3043, Lots 72 and 77 on the NYC Tax map. The Site is approximately 0.57-acre and consists of a vacant commercial building to the south and private parking lots to the north and west. Historically, the Site was developed with residential buildings as early as 1901 and various commercial uses between approximately 1915 through August 2023. Historical Site operations included a printing facility on the southeastern portion of the Site between and a dry cleaner in the northeastern portion of the Site. The Site buildings became vacant in August 2023.

The proposed redevelopment plan includes demolition of the existing buildings and construction of a 10- to 14-story mixed-use residential and commercial building containing affordable and supportive housing units with exterior surface grade parking.

Summary of the Investigation: The primary contaminants of concern at the Site are semi-volatile organic compounds (SVOCs), polychlorinated biphenyls (PCBs) and metals in soil site-wide; and tetrachloroethylene (PCE) and trichloroethylene (TCE) in groundwater.

Brownfield Cleanup Program: New York’s Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as “brownfields” so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.

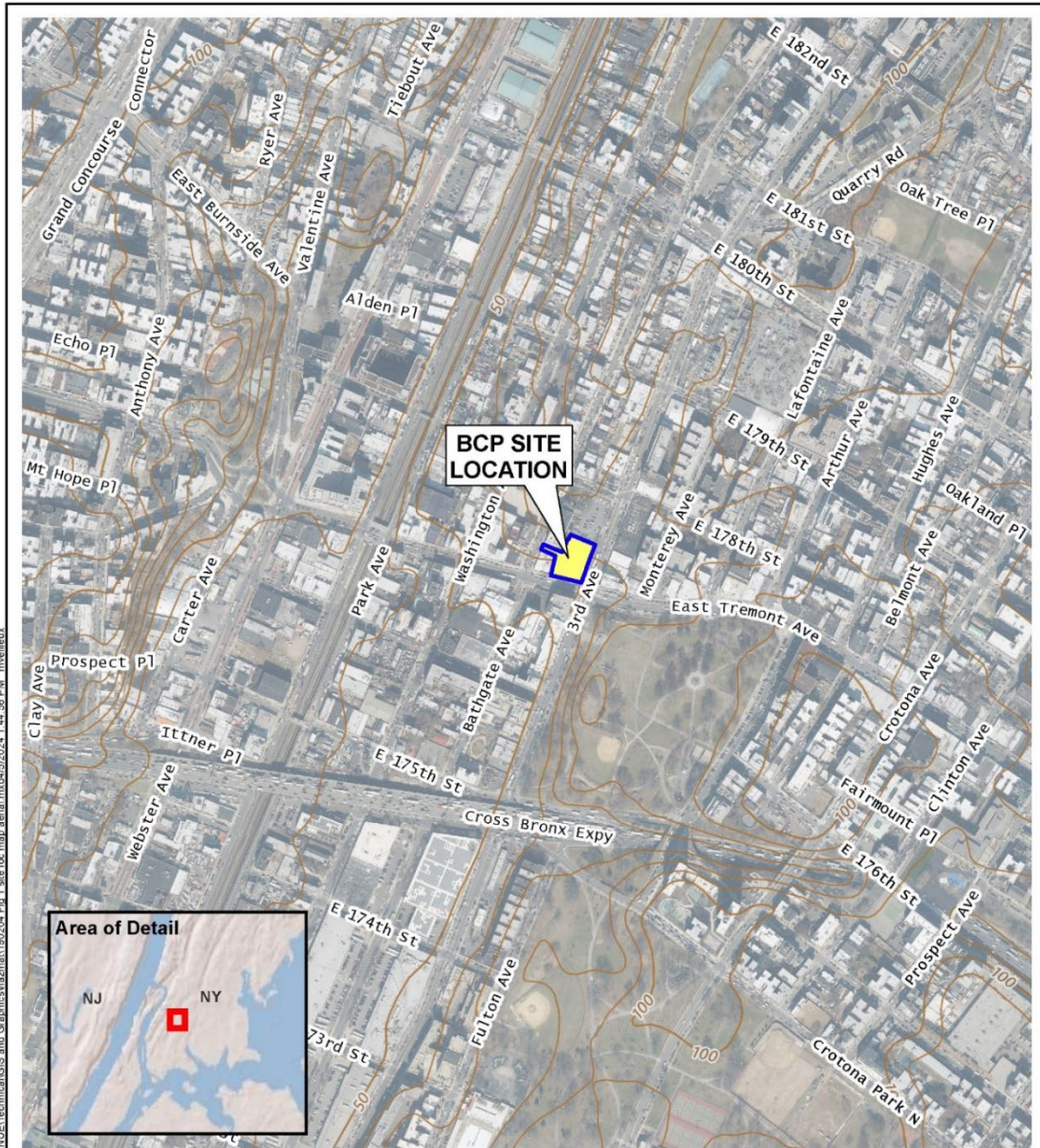

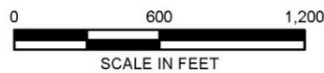
