1. Introduction

P.W. Grosser Consulting, Inc. (PWGC) has prepared this monthly progress report on behalf of J&H Holdings Company, LLC ("Participant") to summarize Brownfield Cleanup Program related work performed at Former Watermark Designs ("Site") for the month of September 2013.

The subject site is located at 491 Wortman Avenue in the City of New York, New York. The site is located within the Brighton Beach neighborhood within the Borough of Brooklyn (Kings County). The property is identified as Block: 4384 Lot: 31 and 36 by the New York City Department of Assessment. The site is approximately 0.44 acres in area and is partially occupied by Crown Ministries International, Inc., a religious organization. A Vicinity Map is included as **Figure 1**. The site is improved with a one-story industrial building with a partial basement. The building was formerly utilized by Watermark Designs for the production of water fixtures.

2. Remedial actions relative to the Site during this reporting period

Remedial actions being performed during this reporting period include:

- Initiation of the Supplemental Remedial Investigation, including:
 - o Investigation of truck scale covered by steel plating
 - o Performance of on-site borings for the collection of soil and groundwater samples
 - o Installation of three water table monitoring wells (one on-site and two off-site)
 - o Installation of two multi-level monitoring wells (one on-site and one off-site)
 - o Installation and sampling of two off-site soil vapor points
 - Performance of off-site (adjacent property) sub-slab vapor and indoor air sampling
 - o AST investigation in basement
- Implementation of NYSDEC-approved Interim Remedial Measure including installation and start-up of three indoor air filters in the eastern portion of the building.
- On-site indoor air sampling to determine the effectiveness of the newly-installed air filters.

3. Actions relative to the Site anticipated for the next reporting period

Remedial actions anticipated for the next reporting period include:

- Completion of Supplemental Remedial Investigation, including:
 - o Sampling of groundwater monitoring wells
- Evaluate Supplemental Remedial Investigation findings and discuss with NYSDEC to determine appropriate remedial alternatives to be addressed in a Remedial Action Work Plan.
- Evaluation of indoor air sampling results with NYSDEC and determination of additional indoor air sampling frequency, if any.





4. Approved activity modification (changes of work scope and/or schedule)

There were no activity modifications during this reporting period.

5. Results of sampling, testing and other relevant data

There are no available results or relevant data available at this time.


