Remedy Proposed for Voluntary Cleanup Site Contamination; Public Comment Period Announced

The public is invited to comment on a proposed remedy being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to address contamination related to Operable Unit 1 at the Kings Plaza Shopping Center/Marina (the "Site") located at 5100 Kings Plaza, Brooklyn, NY. Please see the map for the site location. Documents related to the cleanup of this site can be found at the location(s) identified on the left-hand side of this page under "Where to Find Information."

How to Comment: NYSDEC is accepting written comments about the proposed plan for 30 days, from **May 9** through **June 9, 2016**. The proposed plan is available for public review at the location(s) identified on the left-hand side of this page under "Where to Find Information." Please submit comments to the NYSDEC project manager listed under Project Related Questions in the "Who to Contact" area on the left-hand side of this page.

Draft Remedial Action Work Plan: The cleanup plan is described in a detailed "Remedial Action Work Plan". The proposed remedy consists of:

- Excavation and off-site disposal of soils contaminated with petroleum and chlorinated volatile organic compounds;
- Localized dewatering, if required to facilitate excavation, and treatment of groundwater prior to discharge to the municipal sewer system;
- Collection and analysis of soil samples to document remaining soil conditions;
- Backfilling excavations with clean, imported fill;
- Installation and operation of a soil vapor mitigation system to address the potential for vapor migration in the adjacent mall buildings;
- Placement of a chemical oxidant to treat remaining soil and groundwater impacts;
- Groundwater monitoring to document effectiveness of the remedy;
- Implementation of plans to protect worker and public health and safety throughout the remedial activities;
- Maintenance of the existing Site cover system consisting of asphalt pavement and sidewalks to prevent exposure to residual contaminated soil; and
- Implementation of long-term Institutional Controls in the form of an Environmental Easement and Site Management Plan.

VOLUNTARY CLEANUP PROGRAM

The proposed remedy was developed by Brooklyn Kings Plaza LLC (the "volunteer(s)") after performing a detailed investigation of the site under New York's Voluntary Cleanup Program (VCP). A "Remedial Investigation Report", which describes the results of the site investigation, was submitted concurrently with the Remedial Action Work Plan and is also available for review at the locations identified on Page 1.

Site Description: The Site is an approximately 1-acre portion of the larger 31-acre parcel of land encompassing the shopping center and is identified as the eastern portion of Block 8470, Lot 55. Operable Unit (OU)-1 consists of the central and southern portions of the East 55th Street mall access road, and is bound by OU-2 to the north, Mill Basin to the south, the mall building to the west, and the Lowe's building to the east. Prior to 1907 the Site was part of Mill Creek, and was developed by the Standard Oil Company of New York between 1930 and the late 1960s, Presto Plastics from approximately 1940 until the late 1960s, and a garage and an auto repair facility circa 1950. The current mall buildings were constructed in the late 1960s.

Summary of the Investigation: The primary contaminants of concern at the Site are petroleum-related and chlorinated volatile organic compounds (VOCs) and semi-volatile organic compounds (SVOCs), which are present in soil, soil vapor and groundwater. Separate-phase petroleum product has been identified on top of the water table in some of the groundwater monitoring wells.

Next Steps: NYSDEC will consider public comments, revise the cleanup plan as necessary, and issue a final Decision Document. NYSDOH must concur with the proposed remedy. After approval, the proposed remedy becomes the selected remedy. The draft RAWP is revised as needed to describe the selected remedy, and will be made available to the public. The applicant(s) may then design and perform the cleanup action to address the site contamination, with oversight by NYSDEC and NYSDOH.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Voluntary Cleanup Program: New York's Voluntary Cleanup Program (VCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield is any real property that is difficult to reuse or redevelop because of the presence or potential presence of contamination.
