As part of the Of the NYSDEC-approved Remedial Action Work Plan and modifications, Roux Environmental Engineering and Geology D.P.C. (Roux) performed environmental oversight and operated air monitoring equipment in compliance with the Community Air Monitoring Plan (CAMP) during foundation installation activities.

RAWP Activities Performed:

- Kingdom continued placing forms for concrete walls and poured these walls in the afternoon.
- Concrete contractor placed lattice structure on second floor to prepare to pour more nonstructural concrete.
- Kingdom performed minor soil movement today to prepare for pouring concrete.

CAMP Performed:

• CAMP was performed for the duration that Roux was onsite observing intrusive work. No exceedances of particulates or VOCs were recorded.

Upcoming work activities:

- Kingdom will remain onsite through approximately 1Q 2023 to complete SSDS, vapor barrier, and foundation slab installation.




Photo 1: Status of forms installation in grid B3 and minor soil movement after concrete pouring.



<u>Photo 2:</u> Office space on floor 2.concrete poured on Friday.


