As it is produced at our Pompton Lakes quarry ASTM#2 is manufactured to meet New Jersey Department of Transportation (NJDOT), New York State Department of Transportation (NYSDOT), and ASTM Standard Specifications.

Pompton Lakes quarry supplies 100% virgin granite (Gneiss) that is quarried and processed to finished sizes. Material shipped from our Pompton Lakes facility is clean and free of contaminants prior to loading. Our Pompton Lakes (8-57R) quarry was approved by the NYSDOT under Test No.19AR060 and the letter to this effect is attached.
