## **Cleanup Action Completed at Brownfield Site**

Action has been completed to address the contamination related to the 19 Patchen Avenue site ("site") located at 19 Patchen Avenue, Brooklyn, NY, under New York State's Brownfield Cleanup Program (BCP). Please see the map for the site location.

Cleanup activities were performed by 19 Patchen GP LLC ("applicant(s)") with oversight provided by the New York State Department of Environmental Conservation (NYSDEC). The applicant(s) has submitted a draft Final Engineering Report (FER) for NYSDEC review which states that cleanup requirements have been or will be achieved to fully protect public health and the environment for the proposed site use.

**Highlights of the Site Cleanup:** The following activities have been or will be completed to achieve the remedial action objectives:

- Installation of both on-site and off-site sub-slab depressurization systems (SSDS);
- Maintenance of the existing site cover system;
- Installation of a vapor barrier/concrete epoxy sealant;
- Rerouting of dry-cleaning ventilation exhaust above the building roof line;
- Development of a Site Management Plan (SMP) for long-term management of residual contamination as required by the Environmental Easement, including plans for: (1) Institutional and Engineering Controls (IC/ECs); (2) monitoring; (3) operation and maintenance; and (4) reporting; and
- Recording of an Environmental Easement to prevent future exposure to any contamination remaining at the site and to ensure implementation of the SMP.

**Next Steps:** When NYSDEC approves the FER, it will be made available to the public (see "Where to Find Information"). NYSDEC then will issue a Certificate of Completion (COC) that will be announced in a fact sheet. The applicant(s) would be able to redevelop the site after receiving a COC. In addition, the applicant(s):

- Will have no liability to the State for contamination at or coming from the site, subject to certain conditions; and
- Will be eligible for tax credits to offset a portion of the costs of performing cleanup activities and for redevelopment of the site.

A COC may be modified or revoked if, for example, an applicant does not comply with the terms of its Brownfield Cleanup Agreement with NYSDEC.

**Site Description:** The 0.042-acre site is located in a mixed residential and commercial area in Brooklyn, and is bounded by Patchen Avenue to the west, Van Buren Street to the north, commercial and residential buildings to the east, and residential buildings to the south. The site is developed with a four-story building with commercial space on the first floor, and residential spaces on the first floor and above. The site use has been mixed residential and commercial since 1908, with a dry-cleaning facility operating for 55 years.

These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
