#### 1. Introduction

In accordance with Article XI – Progress Reports of the 03 February 2016 Brownfield Cleanup Agreement (BCA) for the above-referenced site, Langan Engineering, Environmental, Surveying, Landscape Architecture and Geology, D.P.C. (Langan) prepared this monthly progress report (MPR) on behalf of PLAX B25, LLC (Participant) to summarize the work performed at 4-40 44<sup>th</sup> Drive, Long Island City, New York (the site) during March 2021.

The site (Block 25, Lot 15) is located in the Long Island City neighborhood of Queens, New York and consists of an irregularly-shaped, 202,500-square-foot (±4.65-acre) lot. The site is located on the city block bordered by 44<sup>th</sup> Drive and 45<sup>th</sup> Avenue to the north, 5<sup>th</sup> Street and Vernon Boulevard on the east, Anable Basin to the south, and the East River to the west. The site is currently occupied by single- and multi-story industrial and manufacturing buildings and a parking lot. Elevations at the site range from elevation (el) 9 feet in the northeast part of the site near 45<sup>th</sup> Avenue to about el 6.5 feet in the southern and western part of the site near the East River and Anable Basin. All elevations presented herein are measured in feet and referenced to the North American Vertical Datum of 1988 (NAVD88). A site location map is attached to this progress report as Figure 1.

## 2. Remedial Actions Relative to the Site Completed during this Reporting Period

On March 25, 2021, investigation derived waste (IDW) generated during Supplemental Remedial Investigation (SRI) No. 3 was transported off-site by AARCO Environmental Services Corp. (AARCO) to the Dale Transfer Corp. transfer station in West Babylon, New York for future disposal at a permitted disposal facility.

#### 3. Actions Relative to the Site Anticipated for the Next Reporting Period

Langan will continue to update the draft Remedial Investigation Report (RIR) with the results from SRI No. 3.
