1. Introduction

In accordance with the reporting requirements of the Brownfield Cleanup Agreement (BCA) for the above-referenced site, Langan Engineering, Environmental, Surveying, Landscape Architecture, and Geology D.P.C. (Langan) prepared this progress report on behalf of BFC 475 Residential LLC to summarize the work performed at 475 Bay Street and 31 Wave Street, Staten Island, New York (the site) from August 1 through August 31, 2021.

The site is located in the Stapleton Heights neighborhood of Staten Island and occupies the Borough of Staten Island Department of Finance Tax Map Block 488, Lots 9, 157, 162 and 164. The site occupies a footprint of 66,800 square feet and is bound by a two-story commercial building and a one-story industrial building to the north; New York City Transit (NYCT) elevated Staten Island Rail structure to the east; Wave Street and a two-story McDonalds restaurant to the south; and Bay Street to the west. A Site Location Map is provided as Figure 1.

The BCA was executed on November 12, 2020. The final Remedial Investigation (RI) Report was submitted to NYSDEC on August 24, 2021. A draft Remedial Action Work Plan (RAWP) was submitted to NYSDEC on August 11, 2021. Public comment on the Remedial Action began on August 25, 2021.


The public comment period for the Draft RAWP began on August 25, 2021 and will run through October 10, 2021.
