Tentative Schedule of Upcoming Work Activities

On behalf of JLJ Management, Kleinfelder East, Inc. wishes to inform you of remedial investigation activities planned at the Orangeburg (Orangetown) Shopping Center site located at the southeast corner of Orangeburg and Dutch Hill Roads in the Town of Orangetown, Rockland County, New York. This site is a participant in the New York Brownfield Cleanup Program (BCP). These work activities are described in the Remedial Investigation (RI) Work Plan prepared for the site and accepted by the New York State Department of Environmental Conservation (NYSDEC) and the New York State Department of Health (NYSDOH). Highlights and Tentative Schedule of Upcoming Activities

The tentative schedule of RI work activities includes:

1) Subsurface soil investigation – week of September 24th 2007.

- 2) Post-subsurface soil investigation groundwater sampling early October 2007.
- 3) Air sampling program late October and early November 2007.

The investigation will be performed by JLJ Management Company, Inc. and its environmental consultant, Kleinfelder East, Inc. with oversight by NYSDEC and NYSDOH.

There will be large equipment present on the work site during the subsurface soil investigation, and access of tenant and certain nearby residence basements for indoor air sampling may be requested. Tenants and nearby residents will be contacted in advance to request access. Workers will identify
