DEC's Division of Environmental Remediation (DER) now distributes information about contaminated sites *electronically by email*.

You must sign up for the DER email listserv:

DER cannot register your email address - only the email address owner can do so. If you already have signed up for the listserv for the county in which the site is located, you need do nothing.

- Get site information faster and share it easily;
- Receive information about all sites in a chosen county - read what you want, delete the rest;
- It helps the environment and stretches your tax dollars.

If “paperless” is not an option for you, call or write to the DER project manager identified in this fact sheet. Indicate that you need to receive paper copies of fact sheets through the Postal Service. Include the site name in your correspondence. The option to receive paper is available to individuals only. Groups, organizations, businesses, and government entities are assumed to have email access.

Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the 130 Midland Avenue site (“site”) located at 130 Midland Avenue, Port Chester, Westchester County. Please see the map for the site location.

Draft Investigation Work Plan: The draft investigation work plan, called a “Remedial Investigation Work Plan,” (RIWP) was submitted to NYSDEC under New York’s Brownfield Cleanup Program. The investigation will be performed by 130 Midland Ave Owner LLC. ("applicant") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

How to Comment: NYSDEC is accepting written comments about the Draft RIWP for 30 days, from **June 2, 2021 through July 2, 2021.**

Highlights of the Proposed Site Investigation: The investigation will define the nature and extent of contamination in soil, surface water, groundwater and any other parts of the environment that may be affected.

Previous investigations have detected semi-volatile organic compounds (SVOCs) in soil and volatile organic compounds (VOCs) in soil vapor and groundwater on site.

Key components of the investigation work include:

- Sampling of surface and subsurface soil sampling, as needed;
- Conducting a soil vapor intrusion investigation; and

- Installing and sampling groundwater wells to monitor impacts from areas of concern on-site.

Next Steps: NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan. NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented.

When the investigation is completed, a report will be prepared and submitted to NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a proposed cleanup plan, called a "Draft Remedial Work Plan" will be developed. The cleanup plan will include an evaluation of the proposed site remedy, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description: The site is a 6.23-acre parcel bordered on the east by Midland Avenue, on the west by the Metro North Railroad, and on the north and south by commercial properties. It is currently developed with a one-story commercial strip mall and a parking lot. The BCP applicant, 130 Midland Ave Owner LLC, currently utilizes a portion of the site to operate a pizzeria and a liquor shop. Historic site uses include a power plant, a railroad car barn, coal storage, a paint shop, bus storage and repair, nut and bolt manufacturing, dry cleaning, restaurants, and a grocery store.

Brownfield Cleanup Program: New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
