DEC's Division of Environmental Remediation (DER) now distributes information about contaminated sites *electronically by email*.

DER cannot register your email address - only the email address owner can do so. If you already have signed up for the listserv for the county in which the site is located, you need do nothing.

## **Interim Remedial Measure Proposed; Public Comment Period Announced**

The New York State Department of Environmental Conservation (NYSDEC), in consultation with the New York State Department of Health (NYSDOH), is proposing an expedited cleanup of contamination at the Block 417 New Rochelle site (“site”) located at 327-329 Huguenot Street, New Rochelle, Westchester County. Please see the map for the site location. NYSDEC is conducting a public comment period because this Interim Remedial Measure (IRM) is likely to represent a significant part of the cleanup for the site. The activities will be performed by RFMCH Huguenot Property Owner II LLC and RFMCH Huguenot Development Partners II LLC (“applicants”) with oversight provided by NYSDEC.

**How to Comment:** NYSDEC is accepting written comments about the proposed plan for 30 days, from **August 18** through **September 18, 2021**.

**Interim Remedial Measure (IRM) Work Plan:** An IRM is a cleanup activity that may be performed when a source of contamination or exposure pathway (the way in which a person may contact contamination) can be effectively addressed without extensive investigation and evaluation.

The IRM work plan describes proposed cleanup activities that include:

- Excavation and off-site disposal of approximately 11,00 cubic yards of contaminated soil to bedrock, which is located approximately 15 feet below surface grade;
- The removal of any underground storage tanks (USTs) that may be encountered;
- Collecting and analyzing end-point soil samples to evaluate the effectiveness of the remedy;
- Importing clean material that meets the established soil cleanup objectives for use as backfill; and

- Implementing a Health and Safety Plan and Community Air Monitoring Plan during all ground intrusive activities.

**Site Description:** The 0.344-acre site is bordered on the south by Centre Avenue and on the east by Huguenot Street. The site is currently being used as a parking lot and contains no structures. The site was used for residential purposes (apartment building) in the early 1900s until 1990 when the City of New Rochelle acquired the site, demolished the building, and converted the site into a parking lot. The anticipated redevelopment includes a mixed-use residential/commercial apartment building.

**Summary of the Investigation:** The primary contaminants of concern at the site are semi-volatile organic compounds (SVOCs), metals, and pesticides which are present site-wide in soil and groundwater. The SVOCs and metals are likely related to historic fill. Pesticides are likely from historic use on the property. Additional investigation of the site will be completed by the applicants prior to implementation of the IRM.

**Next Steps:** NYSDEC will consider public comments, revise the plan as necessary, and approve the IRM work plan in consultation with the New York State Department of Health. The approved work plan will be made available to the public (see "Where to Find Information" on the front page).

When the expedited cleanup activities are completed, a Construction Completion Report will be prepared that documents the activities that were performed.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

**Brownfield Cleanup Program:** New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.

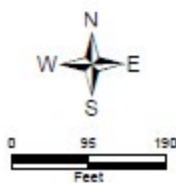
