Subject: Groundwater Monitoring Program Adjustments Approval, Troy Belting and Supply, C401067

NYSDEC and NYSDOH have reviewed the 4th Quarter 2018 Groundwater Monitoring Report (Q4 2018 GW Report) submitted for the Troy Belting and Supply Company (Troy Belting) BCP site (site #C401067). The Q4 2018 GW Report was submitted by Sterling Environmental Engineering, P.C. (Sterling) on behalf of Troy Belting on March 29, 2019. A reduction in the groundwater monitoring program was requested in the Q4 2018 GW Report, and NYSDEC/NYSDOH have considered that request.

Given that the 1st Quarter 2019 groundwater monitoring event will be performed within the next several days, and given that any pending remedial action discussion/review/approval will likely require further changes in the groundwater monitoring program for this site, NYSDEC hereby approves of the following groundwater monitoring program adjustments until further notice:

1. Quarterly sampling will be adjusted to semi-annual and annual sampling, such that **Each April and October**, groundwater monitoring wells 4S, 6S, 6D, 6D', 7S, 7D and 8S will be sampled as per previously-approved protocols; and **Each April**, groundwater monitoring wells 3S, 5S and 10D will be ADDED to the sampling event;
2. Analyses will remain as volatile organic chemicals (VOCs) using USEPA Method 8260C (but with 1,4-dioxane results not reported from this method) PLUS 1,4-Dioxane using USEPA Method 8270D SIM for each sampled groundwater monitoring well;
3. All existing groundwater monitoring wells will continue to be checked and recorded for Depth to Groundwater during each sampling event (as has been done previously); and
4. Groundwater monitoring data will continue to be reported (as per previously-established procedures) following each sampling event.

Please let me know if there are any questions regarding the above changes and clarifications for the groundwater monitoring program for the Troy Belting BCP site.
