NYSDEC Certifies Cleanup Requirements Achieved at Brownfield Site

The New York State Department of Environmental Conservation (NYSDEC) has determined that the cleanup requirements to address contamination related to the 130 Main Street site ("site") located at 106 Main Street in Buffalo, Erie County, under New York State's Brownfield Cleanup Program have been met. Please see the map for the site location.

The cleanup activities were performed by 130 Main Environmental Remediation, LLC, Heritage Point Canalside, LLC, and 130 Main Master Developer, LLC ("applicants") with oversight provided by the New York State Department of Environmental Conservation (NYSDEC). NYSDEC has approved a Final Engineering Report (FER) and issued a Certificate of Completion (COC) for the site.

Completion of the Project: The following activities have been completed to achieve the remedial action objectives:

- Excavation Excavation and off-site disposal of about 24,290 tons of contaminated soil and historic fill material exceeding the Unrestricted Commercial Use soil cleanup objectives, the site-specific cleanup criteria. Clean fill was brought in to replace the excavated soil and historic fill material and to establish the design grades at the site.
- Groundwater Dewatering System A groundwater dewatering system was installed onsite to control groundwater during remediation. The dewatering system will be decommissioned once the concrete for the second floor of the building is set.

BROWNFIELD CLEANUP PROGRAM

Final Engineering Report Approved: NYSDEC has approved the FER, which:

- 1) Describes the cleanup activities completed.
- 2) Certifies that cleanup requirements have been achieved for the site.
- 3) Describes any institutional/engineering controls to be used. An *institutional control* is a non-physical restriction on use of the site, such as a deed restriction, when contamination left over after the cleanup action makes the site suitable for some, but not all uses. An *engineering control* is a physical barrier or method to manage contamination such as a cap or vapor barrier.
- 4) Certifies that a site management plan for any engineering controls used at the site has been approved by NYSDEC.

The site has achieved a Track 1 Unrestricted Use cleanup and does not require any institutional/engineering controls.

Next Steps: With its receipt of a COC, the applicants are eligible to redevelop the site. In addition, the applicants are eligible for tax credits to offset the costs of performing cleanup activities and for redevelopment of the site. A COC may be modified or revoked if, for example, there is a failure to comply with the terms of the order or agreement with NYSDEC.

Site Description: The site is located at 106 Main Street in the City of Buffalo, Erie County and is situated on an approximately 0.491-acre parcel bounded by the Canalside seasonal ice skating rink to the north, Marine Drive to the south, Main Street and the NFTA Metro Rail to the east, and Explore & More Children's Museum to the west. From 1940 until 2009, a portion of the Buffalo Memorial Auditorium was located on the Site. Prior to 1940, the site was developed with commercial structures. The planned redevelopment is a multi-story building with commercial space and apartments.

A brownfield site is any real property where a contaminant is present at levels exceeding the soil objectives other health-based cleanup or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.


