REMEDIAL INVESTIGATION TO BEGIN

The New York State Department of Environmental Conservation (Department), working cooperatively with the New York State Department of Health (NYSDOH), has prepared this fact sheet to update you on upcoming activities at the Hills Holding Corporation Construction & Demolition Debris Landfill located on County Route 42 in the Town of Fallsburg, Sullivan County (Figure 1). The Town of Fallsburg will be conducting a Remedial Investigation (RI) at this Site in 2007 which will focus on finding the nature and extent of environmental contamination from waste in the Landfill. The investigation will be conducted under the Department's Environmental Restoration Program (ERP). For this project, the 1996 Clean Water/Clean Air Act will provide up to 90 % of the funding for on-site activities, and up to 100 % of funding for off-site activities. A RI Work Plan describing investigation activities is available at the repositories listed on the next page. Following the investigation, an RI Report and Alternatives Analysis Report will be generated and made available to the public. The Alternatives Analysis Report will evaluate potential cleanup strategies.

The Hills Holding Corporation Co**BACKGROUND** Debris Landfill is an eight acre Landfill on a property encompassing 26.4 acres abutting the Neversink River and State Route 42. The Site was used as a C&D Debris Landfill during the year 1988. Town of Fallsburg public supply wells are located to the northeast and to the south of the Site. In 2004, the Town of Fallsburg applied to the Department's ERP to conduct a RI and Alternatives Analysis at the site. The town's application for the ERP was approved on May 26, 2005, and on July 3, 2006 the Town of Fallsburg was granted a Temporary Incidence of Ownership, allowing the town to proceed with their RI.

This Remedi**R EVAEDIA WINVESTIGATION HIGHLIGHTS**

Test pitting, borings through the waste mass, surveying, and mapping to define the limits of waste;

- Existing well inspection and new monitoring well installations to enhance the existing monitoring well network;
- Groundwater monitoring well sampling;
- Surface water sampling at nine (9) locations;
- Sediment sampling at eight (8) locations;
- Surficial soil sampling at three (3) locations on the Landfill and six (6) locations on the balance of the property;
- Leachate investigation to identify and sample leachate seeps or areas characterized by stained vegetation;
- Vector investigation to identify any animals present which may carry disease;
- Explosive gas investigation;
- Fish and wildlife impact analysis; and
- Soil vapor assessment.

Following the investigation activities, a Remedial Investigation Report will be prepared. When this report has been approved it will be placed in the document repositories for this Site.


