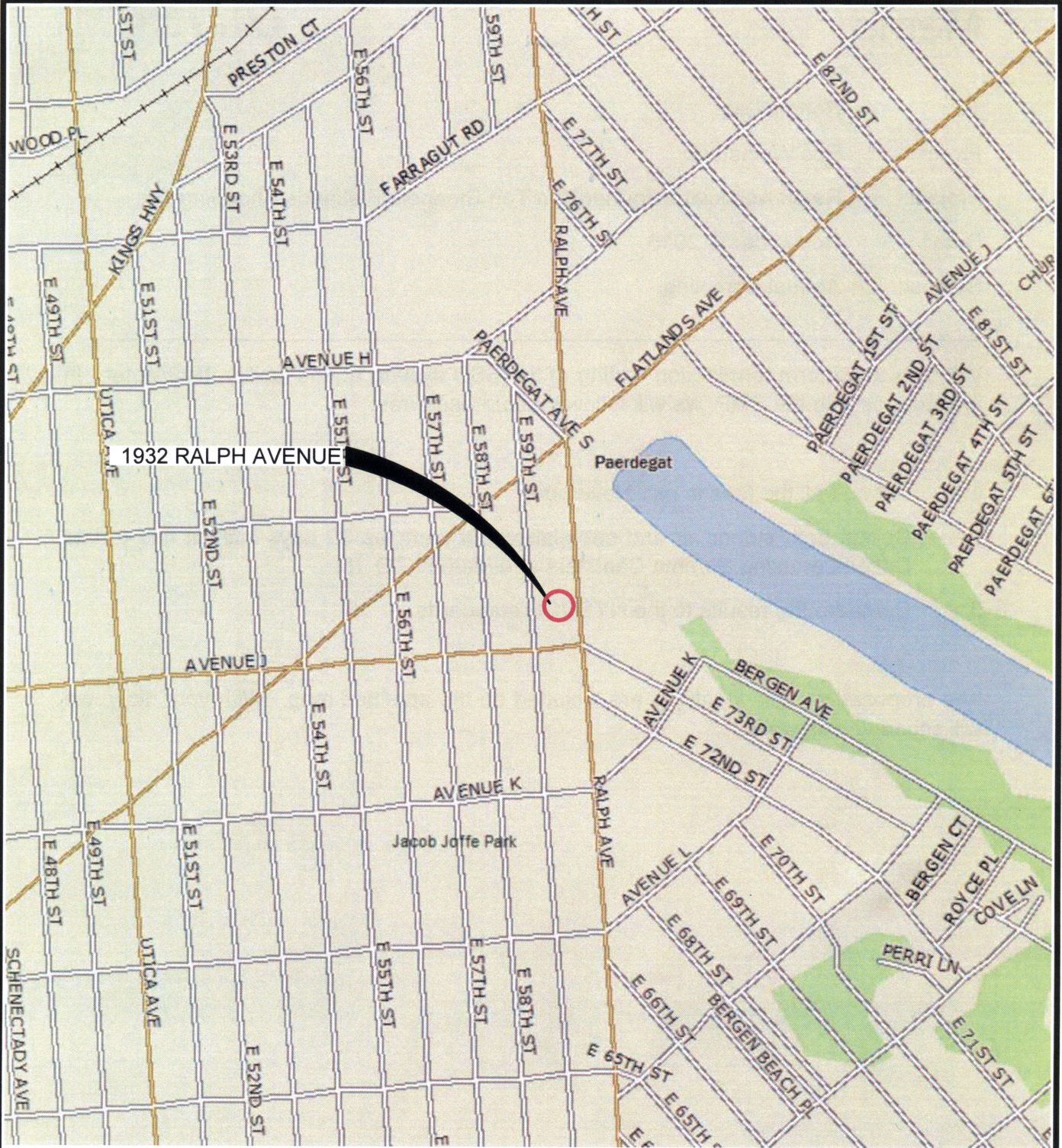
We plan to perform termination testing of the SSD system at this facility this Winter. In accordance with the SMP, we will follow these procedures:

- 1 – Turn off all the fans in mid-November;
- 2 – Collect both indoor air and sub-slab vapor samples 30 days later in mid to late December using Summa Canisters and Method TO-15;
- 3 – Compare the results to the NYSDOH standards.

The proposed sample locations are included on the attached map. With your okay, we will schedule this work.

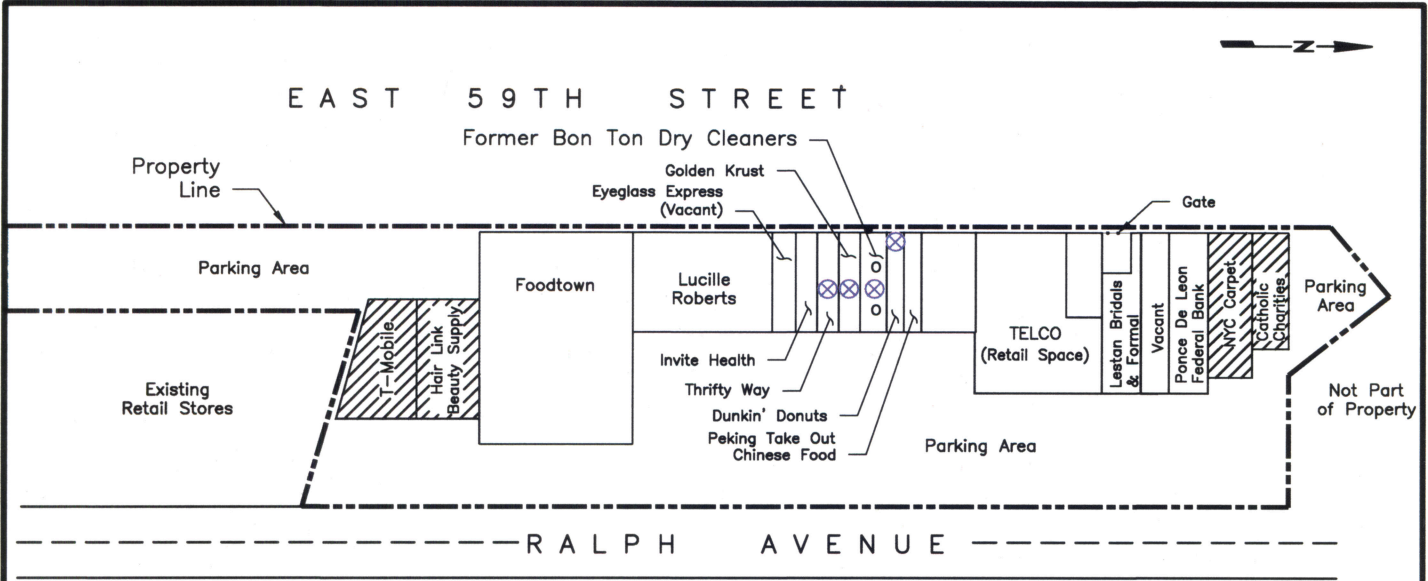

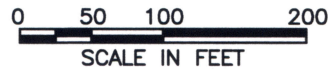
