State Superfund Site Reclassification Notice Class 02 to Class 04

The Inactive Hazardous Waste Disposal Site Program is New York State's Superfund Program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on the attached map, has been reclassified on the Registry as a Class 04 site as it no longer presents a significant threat to public health and/or the environment for the following reason(s):

- Human exposures to residual contamination at the site are being addressed through the implementation of a deed restriction that will limit the use and development of the site and prohibit the use of groundwater at the site as the source of potable or process water without prior approval.
- Future excavations will be conducted in accordance with an excavation plan to ensure that human exposures to residually contaminated soils are properly managed.
- Compliance with the approved site management plan and periodic certification by the County to the New York State Department of Environmental Conservation will ensure that institutional and engineering controls remain effective.

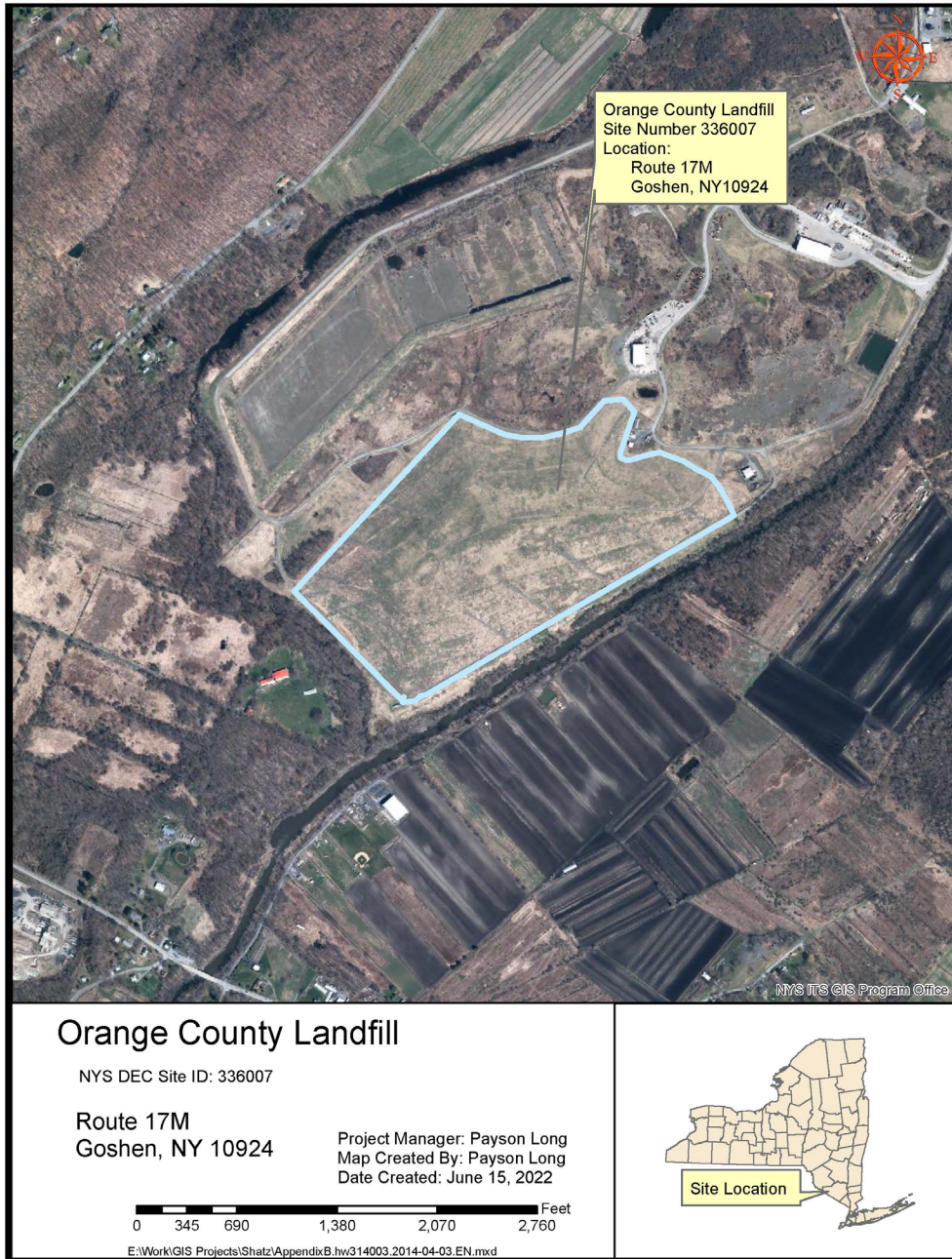
