State Superfund Site Delist Notice

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). DEC has determined that this site (see map on reverse side) no longer presents a threat to public health or the environment and is proposing to delist the site from the Registry for the following reason(s):

- Impacted soils have been excavated and removed from the site and the site-related contaminants are no longer present in groundwater. Remedial actions are complete and no documented source materials remain on site.

Public comments are being received before the decision to remove the site from the Registry is finalized. The public comment period will end **November 4, 2022**. If we do not receive any new or additional information during this public comment period that changes our delist proposal, we will delist the site on or after **December 4, 2022**.

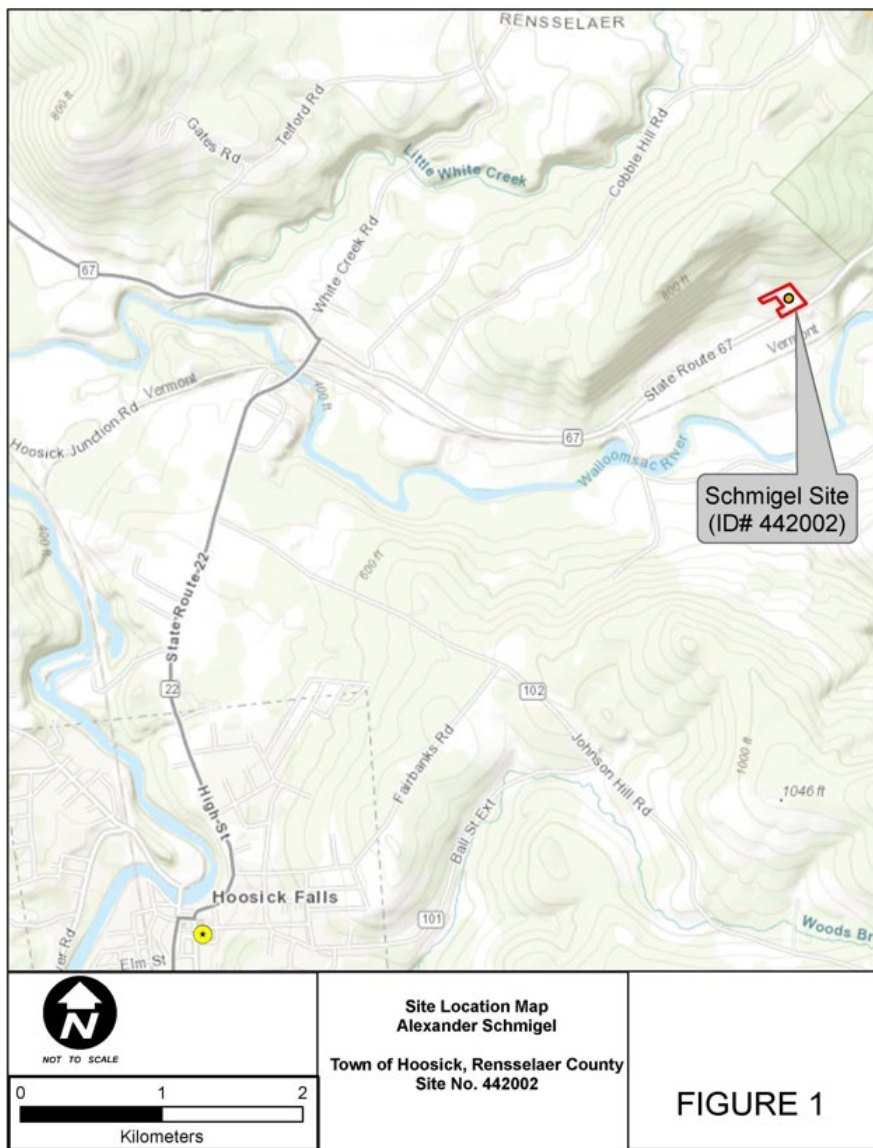
