PUBLIC NOTIFICATION PROPOSED LANDFILL PROJECT TOWNS OF PORTER & LEWISTON NIAGARA COUNTY

The New York State Department of Environmental Conservation (the "Department") has determined the applications pertaining to CWM's proposal to construct and operate a new landfill designated as "Residual Management Unit – Two" ("RMU-2") at its Model City facility to be complete.

As a result, the Department has prepared and is providing in this letter's Enclosure No. 1, a Newspaper Notice, a Radio Announcement and a Fact Sheet which are to be used, as later described in this letter, to provide the public with information regarding CWM's proposed RMU-2 landfill project and the associated regulatory process.

The Department has made a tentative determination to issue a Part 373 Permit Modification for construction and operation of CWM's proposed RMU-2 landfill and other waste storage/treatment units described in CWM's modification application, a Part 663 Freshwater Wetlands Permit and Section 608.9 Water Quality Certification. As a result of this tentative determination, Department staff has prepared a Part 373 DRAFT Permit Modification and a Part 663 DRAFT Freshwater Wetlands Permit / Water Quality Certification (DEC Permit ID 9-2934-00022/00231) for public review as required by 6 NYCRR 621.7(b)(7) of the State regulations. A hard copy of the entire Part 373 DRAFT Permit Modification and Freshwater Wetlands Permit is provided in this letter's Enclosure No. 2, along with a CD disk containing an electronic copy in a "PDF" format.

In order to facilitate commencement of the above described public/regulatory review process, this letter hereby requires CWM, as the project applicant, to perform the following tasks:

- CWM must secure publication of the Newspaper Notice contained in this letter's Enclosure No. 1, as a legal notice, unaltered, at CWM's expense in the Buffalo News and Niagara Gazette on May 7, 2014 for one day and in the Lewiston Porter Sentinel on May 10, 2014 for one day. Once publication occurs, CWM must secure from the newspapers, affidavits of publication and mail them to James T. McClymonds, Chief Administrative Law Judge, NYSDEC Office of Hearings, 625 Broadway, 1st Floor, Albany, New York 12233-1550. Be advised that Department staff will arrange for publication of the Notice in the Department's Environmental News Bulletin (ENB) on or about the same date as the newspapers' publication.
- In accordance with the provisions under 6 NYCRR 621.7(d) of the State regulations, CWM must secure broadcast of the Radio Announcement contained in this letter's Enclosure No. 1, unaltered, at CWM's expense on WJJL, WLVL, WBEN and WGR. The enclosed radio announcement must be broadcast on each of the listed stations at least twice on May 7, 2014, once between the hours of 9:00 a.m. and of 11:00 a.m., and once between the hours of 1:00 p.m. and 4:00 p.m. This must be a paid announcement. Once broadcast occurs, CWM must secure from each of the listed radio stations, affidavits of broadcast and mail them to James T. McClymonds, Chief Administrative Law Judge, at the address indicated under the first bullet.
