- 3. Country Estates Laundromat is a tenant-operated facility located within the Bryant's Country Square Shopping Center, Route 32, Greenville, New York. The laundromat has an on-site wastewater treatment system consisting of a lagoon and open sand filters.
- 4. Respondent is subject to Order on Consent R4-2007-0920-123 (effective October 17, 2007) ("Order"), which contains a Schedule of Compliance.
- 5. Respondent has requested a revision to the Order's Schedule of Compliance allowing for the permanent decommissioning of the on-site wastewater treatment system. The Department finds good cause for agreeing to the revision.
- 6. Respondent has affirmatively waived its right to a hearing in the manner provided by law and has consented to the issuing of this Modification and has agreed to be bound by the terms, provisions, and conditions contained herein.

NOW, being duly advised and having considered this matter, IT IS HEREBY ORDERED THAT:

- I. Respondent shall comply with the Modification's Schedule of Compliance which is incorporated and made part of the terms, provisions, and conditions of this Modification and which supercedes the Order's Schedule of Compliance.
- II. The effective date of this Modification shall be the date it is signed by the Department.
- III. All terms, provisions, and conditions of the Order remain in effect unless expressly modified in this Modification.

SCHEDULE OF COMPLIANCE

- 1. On or before November 1, 2008 Respondent shall cease all discharges to the on-site wastewater treatment system and shall relinquish its SPDES permit to the Department.
- 2. Respondent shall submit for Department review and approval, closure plans developed in accordance with 6 NYCRR Part 750-2.11 for the permanent decommissioning of the onsite wastewater treatment system. Respondent shall complete the closure of the on-site wastewater treatment system no later than December 31, 2008.
- 3. Respondent shall prepare and submit to the Department a construction report which documents all related closure activities including as-built diagrams and disposal records on or before February 28, 2009.
