Comments:

This determination is based upon review of records, observations of New York State Department of Environmental Conservation (NYSDEC or Department) staff of the Facility operations, and/or review of air monitoring data collected from July 1, 2021 through November 31, 2021.

Department staff observed fugitive dust emissions resulting in air contaminants migrating off-site on the following dates:

August 10, 2021 October 18, 2021 October 26, 2021 November 10, 2021 November 22, 2021 December 27, 2021

Department staff observed fugitive dust emissions generated from the baghouse silos on the following dates.

July 28, 2021 August 3, 2021

Total Suspended Particulate samples collected by Department staff at the Saratoga Sites Apartments public housing complex have shown offsite migration of particulate from Norlite. Off site collected samples have matched source samples taken from Norlite. Source samples taken at Norlite include the radial stacker, aggregate fines to silo, baghouse dust, and primary shale fines. Each of the 10 samples taken between 4/4/2021 and 06/15/2021 has resulted in particulate generated from Norlite, including baghouse dust.

Department air monitoring devices located at the Saratoga Sites Apartments public housing complex establish PM10 events attributable to Norlite.

Such events include periods during which Norlite caused off-site air quality to exceed the USEPA Air Quality Index (AQI) PM10 3-hr running average unhealthy for sensitive groups value of 155 ug/m3. There were 22 hours during the time period sampled that exceeded the 3-hour running average of 155ug/m3.

Silica samples collected by Department staff at the Saratoga Sites Apartments public housing complex on the following dates establish Norlite has emitted air contaminants resulting in silica samples above the Department AGC of 2 ug/m3 measured at PM10.

However, failure to immediately comply could result in a larger penalty than would otherwise be assessed, should you be adjudged to be in violation of the ECL.

PLEASE TAKE FURTHER NOTICE THAT you may submit information or evidence to the Department relevant to your compliance record, the nature of the violations, or any mitigating circumstances. Any such information or evidence may be used in a civil enforcement proceeding or criminal action. In the event that formal enforcement proceedings are initiated or criminal charges filed against you, you will have the right to a hearing. You may also request an informal conference to discuss this NOTICE and the events to which it relates.
