Introduction

AECOM Technical Services, Inc. (AECOM), on behalf of Corning Incorporated, has prepared this Pre-Design Investigation Work Plan Addendum Number 4 (PDI Work Plan Addendum 4) for additional field investigation activities within the Study Area¹ to supplement the Pre-Design Investigation Work Plan (PDI Work Plan; January 2018), as amended and approved by the New York State Department of Environmental Conservation (NYSDEC). The PDI Work Plan is being implemented pursuant to the Order on Consent and Administrative Settlement between NYSDEC and Corning Incorporated (December 2017 Order on Consent).

The additional field investigation activities are being conducted at the request of the NYSDEC to gather additional data to assist in defining the extent of Subject Material², and support remedial design.

Under the PDI Work Plan, the process of collecting step-out samples to obtain “end-point” samples was limited by a property boundary. As stated in the NYSDEC-approved PDI Work Plan, step-out sampling ends when “a property boundary and/or property structure is reached.” In the event a property boundary is used to discontinue step-out sampling, NYSDEC is now requiring additional characterization samples be collected at the adjacent property within the Study Area to determine if remedial activities will be required. Category F Characterization samples, a new type of sampling category in the PDI Work Plan, will be collected at discrete locations along property boundaries based on samples collected at the adjacent property.

Category F Characterization samples can include surface soil and/or soil boring samples, and will be collected approximately every 30 linear feet along a property boundary where sampling at the adjacent property indicated the presence of Subject Material or remediation activities

extend to the property boundary. Category F Characterization samples will be sampled consistent with Category B Endpoint samples described in subsection 4.3.2 of the PDI Work Plan.

Based on the current analytical results of adjacent properties, NYSDEC is requiring additional Category F Characterization sampling at the properties listed in Table 1. Additional properties requiring Category F Characterization sampling may be identified based on analytical results of adjacent properties. As additional properties are identified for Category F Characterization sampling, Corning Incorporated will request written consent to access for sampling under PDI Work Plan Addendum 4, and once received, each individual property owner will be notified by AECOM of pending activities on the owner's property.

In addition to Category F sampling, Category B and Category D sampling (as defined in the PDI Work Plan) are also included in PDI Work Plan Addendum 4. Category B and Category D samples are listed in Table 1. The sampling category dictates both the type of sample to be collected and any additional steps needed based on field observations (e.g., if step-out borings are required).

Additional properties requiring Category B and/or Category D Characterization sampling may be identified based on analytical results of adjacent properties. As additional properties are identified for Category B and/or Category D Characterization sampling, Corning Incorporated will request written consent to access for sampling under PDI Work Plan Addendum 4, and once received, each individual property owner will be notified by AECOM of pending activities on the owner's property.

PDI Work Plan Addendum 4 samples will be analyzed by a New York State Department of Health (NYSDOH) Environmental Laboratory Approval Program (ELAP)-certified laboratory, in accordance with the Quality Assurance Project Plan (QAPP) provided in Appendix C of the PDI Work Plan.


Due to the confidential nature of sample collection on private properties, no sampling location maps are included in this PDI Work Plan Addendum 4. The current additional investigation activities are described in tabular form in Table 1. Individual properties are identified by property codes and sampling locations are described using property features and/or previous sampling locations. The sample coordinates have been provided to NYSDEC separately.

Sampling activities will be performed using the methods and procedures described in Section 4 and Appendix D (Standard Operating Procedures) of the PDI Work Plan. Samples will be analyzed for Target Analyte List (TAL) metals plus mercury and Target Compound List (TCL) semi-volatile organic compounds (SVOCs) using the methodologies described in Section 4 and Appendix C (QAPP) of the PDI Work Plan.

Schedule

It is anticipated that the additional investigation activities contained in this document will be performed in the summer of 2020. The additional investigation activities described in this document will be performed based on approval from NYSDEC and receipt of written consent to access from the property owners.
