5. Rescue of Others
6. Weather Precautions, Considerations, and Reactions
7. Motorboat Use (only small boats are considered here)
8. Cleanliness and Sanitation around small craft
9. Invasive species such as Zebra Mussels, Eurasian Milfoil, Etc.

Suggested Outline for Camping Section of NYS Guide Exams

Note: You will need this if you will be out with clients overnight, even if on a guided trip in another specialty.

1. DEC Rules and Regulations regarding overnight camping on State Land
2. Campcraft
3. Sanitary Concerns
4. Winter Considerations



Suggested Outline for Fishing Section of NYS Guide Exams

Note: The NYS Fishing Syllabus may be referred to during this exam. It is recommended that those taking it familiarize themselves with how to reference it to get specific answers to specific questions.

3. Fishing Tackle and Techniques
4. Fish Behavior
5. Fish and Trophy Care
6. Fishing Safety

Note: This certification is required for outings on foot, snowshoes, etc. However, it is **not** required if the activity falls under another guiding specialty such as camping, fishing, or hunting.
